G) Resolution: FISTF Statutes / Constitution 2020.

Information: Voting - Opened Monday, 23 November.

The Vote was done according to existing Statutes 2013.. Vote through FISTF F-IVP (Internet voting poll 2017 tool)

The new Statutes/Constitution 2020 were carried by the Congress 2020, which was the most important change for a democratic and functional FISTF in the future.

Due to several public comments by delegates, it was announced that the Board shall revise or delete several articles after the Congress 2020 votes.

Horst Deimel, the departing General Secretary, confirmed that he will do so accordingly to finalize the Statutes 2020, which he started to revise in 2018.

This includes the proper specification of the Sanction Article (Appeal, Repeal), the definition of votes (cast votes), the voting for the president in case of one or more candidates, the application system for Candidates and other Articles which include mistakes.

The written helpful suggestions of Austrian and Australian delegates prior to the Congress were welcomed. Switzerland's email was neutral on the Statutes 2020.

### J3) Resolution: New Sports playing rules (laws). Version 6.0

The 14 modifications presented by the FISTF Sports Committee were a

difficult subject as they concern every player. Much

discussion took place concerning the interpretation of the sports rules.

FISTF offered several options to vote for implementation with 3 date options.

The options should have been better specified to avoid confusion.

Nevertheless, the result was to implement the 14 modifications with revision durng 2021. Delegates approached the Congress to hear more specialists on rules and take all opinions into consideration. They shall be presented by the Sports committee during 2021 for possible implementation in 2022.

The resolution will be clarified by the new Board of Directors in 2021. It was suggested that modification should not be done as a package, but

as single items

### J4) Resolution: Age Categories changes. Youth & Veterans

The change to the age categories had already been approved by the Board

and was now carried by the Congress 2020.

**Reasoning:** Youth players can participate in U16 and U20 in each, 2x Confed Champion-

ships and 2x in World Cups. This is favoured by all Confederations.

A youth player can play at least 10 years in youth categories.

- I. All FISTF forms must be transferred into Excel sheets to quickly update the database.
- m. Data can be exported and offered to the MNAs only. GDPA must be taken in consideration.n. Mr Luis Horta shall warrent the functioning of the system and maintenance. He must also
- warrent that 2 person (computer programmers) will be trained (introduced) to handle the system at any time. Sustainable maintenance.
- o. A proper handbook or manual will be written to assist with maintenance of the database.
