Preface

Document Basis & Explanation

- The provisions of this handbook apply to FISTF, its Member National Associations, registered players, registered Clubs and competition organisers in the conduct of any activity related to sports table football.
- In case of any conflict between the FISTF Statutes and any other section of this handbook, the provisions of the FISTF Statutes shall prevail.
- If any provision of this handbook or its applicability to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this handbook which can be given effect without the invalid provision or application, and to this end the provisions of this handbook shall be severable.
- In the event of any controversy, dispute or claim arising out of or relating to this handbook, or to the interpretation, breach, or enforcement thereof, the parties shall in good faith use best efforts to settle such controversy, dispute or claim by negotiation. If such negotiation should fail, such controversy, dispute or claim shall be submitted to the FISTF Board of Directors, which shall issue a final, binding and conclusive ruling on all interested parties.
- The rights and obligations herein contained shall inure to the benefit of, and be binding upon, FISTF, MNAs, registered players and registered clubs and their respective executors, administrators, successors and assigns.
- Any forbearance of FISTF, MNAs, registered players or registered clubs to exercise any right or remedy to which they are entitled to under this handbook shall not be construed as a waiver of, or preclude the exercise of, any right or remedy.
- As used in this handbook, words in the masculine gender shall mean and include corresponding neuter words or words in the feminine gender and vice-versa, words in the singular shall mean and include the plural and vice versa, and the word “may” gives sole discretion without any obligation to take any action.
- Any case not provided for in this handbook shall be referred to the FISTF Board of Directors, which shall issue a final, binding and conclusive ruling on the case.

FISTF hereby disclaims any warranties, express or implied, including, without limitation, any implied warranty arising from course of performance, course of dealing or usage of trade, and also disclaims all other obligations and liabilities whatsoever whether in contract, warranty, product liability, tort (including without limitation, negligence, active, passive or imputed liability or strict liability), by statute or otherwise, related to the organisation and conduct of sports table football competitions, except as expressly assumed by FISTF in its statutes or in the present handbook.

MNAs by becoming FISTF members and accepting to organise sports table football competitions, expressly agree that FISTF is released from, and shall not be liable to MNAs or competition organisers upon, any claim howsoever arising out of sports table football competitions, whether in contract, warranty, product liability or tort (including without limitation, negligence, active, passive or imputed liability or strict liability), by statute or otherwise, and all direct, indirect, special, consequential and incidental damages of any nature whatsoever, except as expressly assumed by FISTF in its statutes or in the valid handbook, and MNAs and competition organisers assume all risk and liability whatsoever related to sports table football competition organised by them, that is not expressly assumed by FISTF.

Section 1 Internal Regulations

1 FISTF Departments

1.1 FISTF Board of Directors

- (a) As the representatives of FISTF, the Board of Directors has the authority and the responsibility for the following matters:
- (b) Organisation and administration of the FISTF members (MNAs) and registered players, referees, clubs and supporters;
- (c) Organisation and administration of international sports table football competitions. FISTF will support competitors taking part in competitions by offering well organised and high-quality sports table football;
- (d) Implementing rules of the game and rules of competitions;
- (e) Production and distribution of international official and promotional sports table football newsletters, videos and other digital material;
- (f) Promotion and development of sports table football so that the number of members and registered players, referees, clubs and supporters can increase and to develop recognition of sports table football as a sport by the public;
- (g) Development and support of players' abilities through meetings and specialist high level training camps for players and referees;
- (h) Ensure that sports material is available and distributed and promote a positive image of sports table football.

1.2 Definition of Department

- (a) Each Board Member has their own Department under their supervision, as follows:

- (b) Each Department can create Commissions for the purpose of the management of a predetermined task under that Department.



2 FISTF Commissions

2.1 Definition of Commission

- (a) FISTF Commissions (Committees) are special groups of people (*Commissioners*) invited or nominated by the FISTF Board of Directors to help on determined tasks under the supervision of one of the FISTF Board members who shall have the right to be members of those Commissions.
- (b) It is not mandatory that these members be members of a FISTF MNA.

Section 2 Administrative Regulations

3 FISTF Members

3.1 Type of FISTF Members

- (a) FISTF MNA is the only type of FISTF Member.
- (b) An MNA does not necessarily have to be an independent nation. Examples include Gibraltar, England, Wales, Scotland & Northern Ireland (GBR), Hong Kong & Macau (CHN), Faroe Islands (DEN), Monaco, San Marino & Andorra, etc. As always, applications may be accepted by the Board of Directors and confirmed by the AGM.

3.2 Criteria for the admission as FISTF MNA:

- (a) A Board with at least 3 persons: A President, a Secretary, a Treasurer.
- (b) A Program of sports activities: Organisation of competitions within its national boundaries, and licensing of all players and referees.
- (c) A registered bank account.
- (d) Mandatory FISTF forms, a membership application to become an MNA enclosing its statutes approved by the national authorities of its country.
- (e) The request for affiliation as an MNA must contain a commitment:
 - (i) To comply with statutes, rules and decisions of FISTF;
 - (ii) To observe the laws of the game in force in FISTF.
- (f) An observation period of one-year minimum is required to validate the application for affiliation as an MNA.
- (g) An MNA undergoing the observation period cannot take part in votes at the AGM but may take part in other FISTF voting activity as decided by the Board.
- (h) Each affiliate will be validated annually at the Annual General Meeting of FISTF.
- (i) An MNA shall have a minimum of 12 registered players.
- (j) An MNA shall have a minimum of 2 clubs (with teams).
- (k) An MNA shall aim to have at least a National Championship and National Cup for Individuals and Teams.
- (l) An MNA shall have a webpage or other for sports table football (STF) information purposes.

3.3 Rights of the Member National Associations (MNA)

- (a) All Member National Associations (MNAs) that are members of FISTF may:
 - (i) Organise their own FISTF tournaments and take part in tournaments listed in the FISTF calendar.
 - (ii) Grant licenses to their clubs and players to attend FISTF tournaments.
 - (iii) FISTF will issue an official diploma proving the membership of the MNA each season, upon request.

3.4 Duties of Member National Associations

- (a) At the start of the season each MNA wishing to become or remain an MNA of FISTF must send an information sheet (**Form F01**) and a list of its licensed players and clubs to the FISTF General Secretary (**Form F20**).

3.5 Rules for the Registration of a Member National Association

(a) Guidelines about the Form F01 - MNA Membership Form

- (i) The completion of this form is mandatory to all MNAs in the terms referred in 3.4.
 - (A) The form must be completed with as much detailed information as possible. Some of this information will be published on the FISTF website under the Nations pages.
- (ii) Published data: GDPA (**Form F60**) must be confirmed by each MNA which is responsible for the players and clubs under their authority. All MNA must confirm and send the filled in form to FISTF. FISTF is registered as a club (federation) in Amiens, France,
- (iii) With the **Form F01**, the MNA must send all the following:
 - (A) Picture files, on JPG format:
 - (I) Portrait photo of each Board Member.
 - (II) Photos of national competition winners on the previous season.
 - (B) Documents:
 - (I) Statutes of the MNA.
 - (II) Each MNA needs to be registered as a club (Association) within the juridical laws of that Nation (country). In case that there are no such laws, the MNA must prove such a situation with an appropriate document or reference to government statutes.
 - (III) In case an MNA cannot be registered officially, FISTF will decide case by case. An organisation must be led by a competent Board of Directors to be the home for players. An association cannot be in the ownership of one or two persons.
 - (IV) A private person cannot control an MNA account and financial control. MNA account must be controlled by the MNA Board of Directors.
- (iv) MNA Regulations including the following mandatory information:
 - (A) Registration fee per player and/or per club.
 - (B) Annual fee per player and/or per club or process for confirming membership.
 - (C) The format of the championship, the national cup and the team championship.
 - (D) Who can be selected and how the selection is made to play in the World Cup and various Continental Competitions as defined by each Confederation.
 - (E) How their Board of Directors operates.

- (F) Copy of any documents that shows the MNA's activity during the previous year, such as newspaper cuttings, links to web articles, videos etc.

(b) **Guidelines about the Form F20 – MNA – Licensed Clubs & Players Form**

- (i) The completion of this form is mandatory for all MNAs in the terms referred to in 3.5. It must be submitted to FISTF by 30th September.
- (ii) If MNAs do not send the **Form F20** to FISTF on time, players and teams will be removed from world rankings until the list has been received.
- (iii) MNAs can send monthly updates of the list of licensed players and clubs, including new licenses.
- (iv) In this way new players / clubs registered during the season (after the deadline of September 30th) can participate in FISTF tournaments.
- (v) Changes to **Form F20** must be submitted after the Transfer Deadline, and in the event of the creation of new clubs, with players transferring to the new club.

(c) **Licensed Clubs**

- (i) **Form F20** must include all clubs licensed by the MNA. Clubs not included in the list will not have a FISTF license to play international FISTF tournaments.
- (ii) Every club shall have a unique FISTF license code and maintain the same code from the previous season. This code never changes and cannot be used by other club in the future.
- (iii) The 3 letters of the MNA code, followed by the letter "C" and 3 sequential digits from 000 to 999, compose the structure of the Club license code. For example, valid club license codes for Austria are AUTC001, AUTC002, ..., AUTC999.
- (iv) For each club, it is mandatory to indicate: Full Club Name, Contact Person, Contact Email, Address, City and its logo.
- (v) A club may enter two or more club teams in FISTF events, such as B-Teams.
- (vi) Club B-Teams cannot participate in the European Champions League and Europa League.
- (vii) Participation by B/C etc. teams in Continental Cups outside of Europe is permitted.

(d) **Licensed Players**

- (i) **Form F20** must include all players licensed by the MNA. Players not included in the list will not have a FISTF license to play international FISTF tournaments.
- (ii) Every player shall have a unique FISTF license code and maintain the same code from the previous season. This code never changes and cannot be used by another player in the future.
- (iii) The structure of the Player license code is composed by the 3 letters of the MNA code, followed by 4 sequential digits from 0000 to 9999. For example, valid player license codes for Austria are AUT0001, AUT0002, etc.
- (iv) The inclusion of a date of the birth is mandatory for every player in order for them to be issued a FISTF license.
- (v) Including the email of each player, although not mandatory, is recommended.

- (e) **Foreign players registered with a National Club**
 - (i) The MNA has no authority to grant a FISTF license to a foreign player.
- (f) **Administrative Sanctions for MNAs**
 - (i) If an MNA has not submitted its **Form F20** registration before the indicated deadline, its clubs and individual players will be prohibited from taking part in FISTF tournaments until this is in order.

4 FISTF Licensed Clubs

4.1 Definition of FISTF Licensed Club

- (a) A FISTF Licensed Club is a club officially recognised by its MNA, after which it can be included on the list of the MNA's licensed clubs (FISTF **Form F20**), or, in the case of there being no MNA in its country, the License will be awarded directly by FISTF.
- (b) A FISTF License is valid for one sports season only and must be renewed each season.

4.2 Definition of the Nationality of Clubs

- (a) Regardless of its legal form, a club shall be deemed to have, for the purpose of sports table football, the nationality of the MNA that licenses it to play sports table football.
- (b) Clubs shall be individually responsible to apply for the license to play sports table football. The club shall be issued a license card, the form of which is left to each MNA to decide.
- (c) The MNA of the country where a club is headquartered, providing this MNA is a member of FISTF, shall solely grant the license and the club shall be deemed a member of this MNA after the granting of the license. The club shall remain a member of this MNA until the end of the sports season. It is not permissible to move its headquarters to another country.
- (d) An MNA shall not unreasonably deny a license to a club headquartered within the country it is representing.
- (e) A club headquartered in a country where no sports table football MNA exists, or where the MNA is not a member of FISTF, shall be granted a license directly by FISTF.
- (f) The MNAs are free to ask a yearly fee from each of their clubs.

4.3 Rights of FISTF Licensed Clubs

- (a) All clubs that are members of an MNA of FISTF may take part in all tournaments listed in the FISTF calendar and are included in the world-ranking table.

4.4 Duties of FISTF Licensed Clubs

- (a) Only FISTF licensed clubs can attend FISTF tournaments.
- (b) For the purpose of attending a FISTF tournament, the Club must request a FISTF License from its MNA.
- (c) If there is no MNA in its country, the license must be requested directly to FISTF.

4.5 Rules for the Registration of a Club

- (a) In order to have a FISTF license, a new club shall request their affiliation with the MNA existing in its country.

- (b) Only if there is no MNA in its country, the club shall request their FISTF license directly from FISTF.
- (c) The administrative procedures are as follows:
 - (i) A new Club must complete the **Form F10** and send it to its MNA with its logo when available. After its approval, the MNA shall send the form to FISTF.
 - (ii) For each new season, the MNAs shall request to their clubs to send an update of the **Form F10**. This form shall be sent to FISTF after approval by the MNA.

4.6 Extinction of a club activity

- (a) In the case of the change of the name or other details of a club (president, secretary, address, contacts, or that a club shall cease activity), **Form F11** shall be sent by the club to its MNA and then to FISTF.
- (b) Refer to Rule 5.8 about the situation of the players registered with a club which ceases its activity.

4.7 Administrative Sanctions for Clubs

- (a) A club that takes part in a FISTF tournament without having a valid FISTF license will be fined 30 Euros.
 - (i) The Organisers shall also be counselled to ensure only registered clubs/players are admitted to future events.
 - (ii) Repeat offence will incur a fine of 30 Euros to the Organiser.
- (b) If the offence re-occurs the fine will be increased to 50 Euros for the club.
- (c) Sanctions for further repeat offences will be decided on a case-by-case basis by the current FISTF BoD.
- (d) An unregistered club cannot receive world ranking points.

5 FISTF Licensed Players

5.1 Players Nationality

- (a) Players are entitled to register with the MNA of the country in which the player was either born, is a legal citizen or has been a permanent resident for a period of three (3) consecutive years.
- (b) Players who are citizens shall provide official documentation such as a passport, while those who are not citizens need to provide relevant documents to prove their permanent residency for the required period of three continuous years.
- (c) FISTF reserves the right to request copies of these documents with the submission of the MNA's **Form F20**.
- (d) For all UK players (having the same British citizenship), the requirement for membership shall be the country of birth or the place of residency upon applying for registration for the first time with FISTF.
- (e) For the purposes of players in the UK, 'country' refers to England, Scotland, Wales and Northern Ireland.
- (f) Example: A player who was born in Scotland, but has lived continuously in England for three years, and who chooses to become a registered player, can decide to register with either the SSTFA or the ESA.

- (g) Players who are currently registered with an MNA cannot transfer nationality unless they meet the requirements of section 5.2.
- (h) Any dispute or appeal related to the licensing of players or shall be referred in writing within thirty (30) days to the FISTF General Secretary.
- (i) Notwithstanding the identity of the MNA with which the player registers, the player shall have the right to be a member of any club of their choice, whether or not that club is operating within the country where the player resides, subject to the rules and regulations established by FISTF for membership and transfers to and from clubs.
- (j) Example: Player C has a Belgian citizenship and is licensed by the Belgian MNA (FBFTS). Player C may also be a member of the Washington, D.C., Table Football Club.
- (k) Notwithstanding the club of which the player is a member, the player shall have all the rights and obligations of the other players being granted a license by the same MNA.
- (l) Example: Player C has a Belgian citizenship, is licensed by the Belgian MNA (FBFTS), but is a member of the Washington D.C. Table Football Club. Player C must be authorised by FBFTS to play the Belgian national individual championship.
- (m) By being granted a license by an MNA, the player becomes eligible to represent this MNA in individual and team international competitions, including but not limited to the World Cup, subject to the agreement of the direction of such MNA and to the rules of the competition.
- (n) Example: Player C has a Belgian citizenship, is licensed by the Belgian MNA (FBFTS), but is a member of the Washington D.C. Table Football Club. Player C may be selected by FBFTS to represent Belgium in the World Cup (both for the individual and team competition).

5.2 Change of Nationality

- (a) A player may request to change FISTF recognised nationality under the following conditions:
 - (i) The player can prove, by providing official papers that they have the legal citizenship of the country represented by the MNA that they are applying to become a member of; or
 - (ii) The player can prove by providing official documentation that they are a long-time resident (at least 3 continuous years) of the country represented by the MNA that they are applying to become a member of; and
 - (iii) The player has not changed their FISTF nationality during the last 10 years.
 - (iv) For the purposes of players with British Citizenship, 'country' refers to England, Scotland, Wales and Northern Ireland. Transfers to another MNA within the UK can only be approved if players have resided in one of these 'countries' for at least three years. Citizenship is not a determining transfer factor for players in the UK as they all have the same citizenship (British).

5.3 Players without MNA

- (a) A player having its nationality in a country where no sports table football MNA exists, or where the MNA is not a member of FISTF, shall be granted a license directly by FISTF.

- (b) Example: Player B has a Kenyan citizenship, where no MNA exists. FISTF will grant the player a license on request.

5.4 Rights of FISTF Licensed Players

- (a) All players who are licensed to play sports table football by an MNA member of FISTF may take part in all tournaments listed in the FISTF calendar and be included in the world-ranking table, unless they are under sanction.

5.5 Duties of FISTF Licensed Players

- (a) When taking part in a FISTF tournament, a player must complete a registration form that is submitted to the organiser. If the player has already completed a registration form during an earlier tournament, they should check on the list of registered players provided by the tournament organiser that their details are correct.
- (b) A player is also required at every tournament to sign an enrolment form that is sent to the organiser by FISTF.

5.6 Rules for the Registration of Players

- (a) Players who take part in FISTF events must provide their nationality, club and birth date to FISTF. **All data is mandatory.**
- (b) If a player has not provided their birth date, the player cannot attend any FISTF tournament.
- (c) It is the responsibility of the MNAs to make sure all players have provided the requested data and validate them.
- (d) The list of players (including the full name, address, date of birth, nationality and club) should be sent to the FISTF General Secretary.
- (e) Only the FISTF registration **Form F20** sent exclusively by the MNA is valid for this purpose.

5.7 Rules for Free Agents ("unattached" players)

- (a) A Free Agent is a player that is not registered with any licensed Club.
- (b) If a player wants to become a free agent (player in the individual ranking, but not registered with any club), for the following season, the player shall inform FISTF through the relevant MNA, during the Transfer Period (5.9(a)(vii)). No permission/signature from their existing club shall be needed. **Form F06F** needs to be completed by the player and submitted to their MNA for sending to FISTF.
- (c) A "free agent" may join any club (existing or new) during the Transfer Period (5.9(a)(vii)).
- (d) A new player is automatically registered as a free agent, unless they join a club during their registration. This player can also join a club as per 5.9(a)(vii).
- (e) A non-ranked (a new player who has never played in any individual or team competition) free agent player can join a club during any time during the Sports Season (5.9(a)(i)). If they have participated in any FISTF competition, rule 5.9 applies.
- (f) A player can change their status to free agent only once during a Sports Season (5.9(a)(i)).
- (g) A Free Agent registered longer than 13 months (1 year plus 1 month) may join any club at any time, not just during the transfer period.

5.8 Rules for the players registered with a club which ceased activity

- (a) All players registered with a club which ceased its activity, change their status to “Free Agents” (5.7). These players can keep on playing all FISTF Individuals competitions during the season.
- (b) Registering with a new club shall still respect all rules under 5.9. Therefore a “Free Agent” cannot transfer during the season to play team competitions.
- (c) A team reserves the right to “release” a player from its list of players during the “Transfer Period” (5.9(a)(vii)). In this case, the team is obliged to inform the FISTF (through its MNA) accordingly. The “released” player is then automatically registered as a free agent.

5.9 Rules for the Transfer of a Player between two clubs

- (a) Players may transfer between two clubs subject to the following conditions:
 - (i) A “Sports Season” is the period between the 1st of September and the 31st of August of the following year.
 - (ii) All National Transfer (5.9(a)(iii)) requests shall be made using **Form F06E**. This shall include the list of all transfers of players regarding the MNA in the referred season. When completed, the form shall be sent to FISTF for registration. If the MNA has its own internal transfer form, it can still use it for National Transfers (5.9(a)(iii)). However, the use of **Form F06** for International Transfers (5.9(a)(iv)) is **mandatory**.
 - (iii) “National Transfer” is defined as the transfer of a player between 2 clubs of the same nationality as the player.
 - (iv) An “International Transfer” is every transfer of a player when the former club or new club has a different nationality of the player.
 - (v) In the case of an International Transfer (5.9(a)(iv)), the following procedure must be followed:
 - (A) New club (or player) submits **Form F06** to the player’s MNA.
 - (B) This form must be signed by the player and by an official of the new club. The signature of the official of the former club is not mandatory, but the official still must be informed by being included in the recipient list of the request email. Also, the form must be disclosed to the MNAs of the new and the previous clubs, for their information.
 - (C) Once approved by the MNA of the player, the form is sent to FISTF for registration.
 - (vi) There is no restriction on the number of players that can be transferred within the same MNA.
 - (vii) “Transfer Period” is defined as the time period between the 1st of July and 30th September for all nations, all regions, using Central European Time as the official date. Official date of the transfer is the date of email sent to FISTF, not the date of signature. All correspondence must be received BEFORE 30th September as mentioned above.
 - (viii) If a player wants to transfer to a new club for the following season, they shall submit FISTF **Form F06** to FISTF during the Transfer Period (5.9(a)(vii)). No permission/signature from their existing club shall be needed.

- (ix) A player may only play for one club in FISTF Teams competitions during a sports season (5.9(a)(vii)).
- (x) A player can only make one transfer during a Sports Season (5.9(a)(i)), excluding a Loan Transfer (5.11).
- (xi) Players shall be enrolled anew each season.
- (xii) A player cannot play in any FISTF Teams competition within the next 14 calendar days following the registration with the new club.
- (xiii) New players can join a club at any time during the season, as defined in 5.9(a)(i).
- (xiv) Players may join a newly created club in the period outside of the Transfer Period if they are registered on **Form F20** at the same time as **Form F10** and **Form F20** are submitted by the MNA to FISTF. This is the 'Foundation Members' rule. Players who later want to join this newly created club may only do so during the transfer period. New players (previously unregistered) may join at any time.
- (xv) In extraordinary circumstances, the FISTF Board of Directors reserves the right to take decisions regarding transfers during the season on a case-by-case basis, following a petition of the relevant players. In such cases, if the petition is accepted by FISTF BoD, the transferred player will not be allowed to transfer to a new club for the following season.

5.10 Foreign Player Rule (FPR)

- (a) Foreign players are players who, at the time of the filing of the transfer request, have a different nationality to that of the club to which they are registered, or to which they request to be transferred.
- (b) A club may enrol as many foreign players as they want in a sports season or during a specific Teams competition, but only two foreign players registered with that club may be selected to play with the club team in the same match.
- (c) For UK players, the 'nationality' is as described in 5.1.
- (d) Players who are 'foundation' members of a club (in other words, were present or joined a newly created club and were included on the initial **Form F10** of the club) are exempt from the FPR. However, 're-founding' an existing club does not qualify. FISTF reserves the right to decide on the application for exemptions.
- (e) Players in youth categories who have a different nationality to parents in the same club are also exempt from the FPR.
- (f) Players who are permanent residents of the country in which their club is registered are also exempt. A copy of the Permanent Residency document must be provided to FISTF as proof.
- (g) Players who have resided on a full-time basis, for three years or more, in the country in which their club is registered, are also exempt. However, they must provide applicable legal documentation as proof of this. The Board of FISTF has the right to ask for full and detailed documentations before accepting this exemption.
- (h) Players who live within 50km of their club, even if it is in a different country, are also exempt (Border Rule).

5.11 Loan transfer

- (a) Any registered player may apply for a "loan transfer" to transfer to club for a period not exceeding three months.
- (b) The "loan player" rule is designed for players who intend on spending a short period of time in a different country to their home nation, either for travels, work assignment or extended holiday.
- (c) A player can only ever be given one loan transfer during their playing career.
- (d) They must provide travel documents (transport and accommodation) to prove their domicile during the transfer loan period.
- (e) The loan player can only play for one club during the loan period.
- (f) A loan player can be granted the loan transfer outside of the normal transfer period.
- (g) At the end of the loan transfer period, the player reverts to their original club.
- (h) If the loan player wants to extend the transfer beyond the three months, it can only be approved during the regulation transfer period. (5.9(a)(vii))
- (i) The loan transfer cannot be used as a method to circumvent the normal transfer regulations.
- (j) The application for the loan shall be sent at least two months before the proposed loan transfer to FISTF Sports Director, signed by the player and the target club (**Form F06A**).
- (k) If there are no outstanding financial penalties on the player, the loan may be approved. The approval is up to the discretion of the Sports Director and/or the Board of Directors.
- (l) The period of the loan covers three months from the date of the first tournament at which the player participates.
- (m) The player may participate in individual and team events for the "loan" club and will be designated as being a member of that club. For example, a player from Singapore Lions TFC may apply for a "loan transfer" to Budapest Subbuteo. When the player participates in the event, they will be designated as "Budapest Subbuteo".
- (n) If the player transfers to a club in a country other than their own, the player will be designated as a foreign player as defined in 5.10.

5.12 Formal Contract

- (a) Formal contracts between a club and a player must be registered with FISTF in order to be accepted as valid.
- (b) From the moment the contract is registered, FISTF becomes the referee for every dispute about the referred contract.
- (c) Registration of the contract is free of charge and its details will be kept private between the parties.

5.13 Administrative Sanctions for Players

- (a) A player who takes part in a FISTF tournament without having a valid FISTF license will be fined 10 Euro.
- (b) If the offence re-occurs, the fine will be increased to 30 Euros.
- (c) An event organiser who allows an unregistered player to participate in a FISTF event will be warned in the first instance and then fined 10 Euros for each subsequent

occurrence. All organisers can contact FISTF to confirm national registration of players to comply with entry to FISTF events.

- (d) Failure of a player to strictly comply with the transfer regulations shall lead to automatic disqualification from the event and forfeit the world ranking points from the event in question.
- (e) FISTF reserves the right to apply a different decision if strict application of the rule would lead to unfairness.

5.14 Players with a Disability

- (a) Disability sport classification.
 - (i) Players interested in registering for a disabled license must apply to the Disabled Sport Department to obtain the relevant license, giving proof of disability direct from their National Federation which may need to obtain also a confirmation from the Disabled Organisation in their country. This is to be sent to Federation of International Sports Table Football – Disabled Sports Department, which will communicate with them in order to obtain the necessary license issued by FISTF Sports Department and included in the FISTF World Ranking.
 - (ii) Any National Federation that wishes to stage a disabled event must get full clearance via Disabled Sport and FISTF Sport Departments.
 - (iii) Sports Rules for the game includes specific rules for disabled players. Rules for this Handbook remain, however, the same, unless otherwise specified and until further notice from the Disabled and FISTF Sports Departments. Duration of match will also be the same as normal matches.

- (b) Class Acceptance for Disabled Sports Licence

- (i) **Classes 42 to 46**

Classes 42 to 46 are for athletes with limb deficiencies, such as amputations. In classes 42-44, the legs are affected by impairment. In classes 45-46, the arms are affected. All athletes in the 40s classes compete standing and do not use a wheelchair.

- (A) **Class 42** Competitors in class T42 and F42 have single above knee amputation, combined arm/leg amputation, or comparable leg impairments. The IPC defined this as: "Single above knee amputees and athletes with other impairments that are comparable to a single above knee amputation. This includes athletes with loss of muscle power in the lower limbs consistent with Class F57 or F58 class."
 - (B) **Class 43** Competitors in class T43 and F43 have double below knee amputation (or combined arm/leg amputation) or comparable leg impairments.
 - (C) **Class 44** Competitors in class T44 and F44 have single below knee amputation or those that can walk with moderately reduced function in one or both legs.
 - (D) **Class 45** Competitors in class T45 and F45 have double above elbow or double below elbow amputations or similar disabilities.
 - (E) **Class 46** Competitors in class T46 and F46 have single above or below the amputations or have normal leg function but impairment in the arms/trunk

(ii) **Classes T51-54 and F51-58**

The 50s sport classes only include athletes competing in a wheelchair. A lower number indicates a higher activity limitation.

- (A) **T51-52** These athletes have activity limitations in both lower and upper limb.
- (B) **T53** These athletes have normal arm and hand function, no or limited trunk function, and no leg function.
- (C) **T54** Athletes competing in T54 have partial trunk and leg function.
- (D) **F53** Athletes in this class have mild limitation of hand function – no leg or trunk function.
- (E) **F54** Athletes in this class have normal function in their arms and hands with no leg or trunk function.
- (F) **F55** These athletes have normal arm function, the ability to rotate the spine, and no leg function.
- (G) **F56** These athletes have normal arm function, the ability to rotate the spine, can move backwards and forwards, and no leg function.
- (H) **F57** These athletes have normal arm, hand, and near normal trunk function. They have increased leg function as compared to F56.
- (I) **F58** These athletes have normal arm, hand, and trunk function with more leg function than F57.

6 FISTF Licensed Referees

6.1 Definition of FISTF Referee Categories

- (a) FISTF defines two different referee categories as follows:
 - (i) Head Referee.
 - (ii) Referee.

6.2 FISTF Head Referee

- (a) **Definition of FISTF Head Referee**
 - (i) During every FISTF event, there must be at least a competition Head Referee to supervise all aspects of refereeing. Their job, during the event, is to:
 - (A) Take decisions about rules.
 - (B) Take decisions about behaviour of players, coaches and referees.
 - (C) Take decisions about equipment used by players.
 - (D) Support the Tournament Manager in appointing referees.
 - (E) Inform players and coaches about referee rights and duties.
 - (F) Submit reports to FISTF about players, coaches and referees.
 - (G) Monitor players', coaches' and spectators' behaviour.
- (b) **Appointing of Head Referee**
 - (i) Head Referee(s) will be appointed as described in this handbook for each type of tournament category (see 9.3(c), 9.5(d))

- (ii) Appointed Head Referee(s) name(s) and Club(s) shall be noted in the tournament venue during the competition.
- (c) **Rights of Head Referee**
 - (i) Head Referees shall be the only person entitled to make reports about referees during matches and submit them to the Disciplinary Council.
 - (ii) A Head Referee will give a first warning to a referee in the following cases:
 - (A) is not focused on their assigned game
 - (B) leaves the table area during a match
 - (C) gives evaluative comments on a player/match
 - (D) is not respectful to players/coaches/spectators
 - (E) fails to compile and/or deliver the match report
 - (F) is unaware of current FISTF Sports Rules.
 - (G) Behaves in an unsportsmanlike behaviour, or consumes alcohol.
 - (iii) In case of a second warning for the cases at 6.2(c)(ii) during the same FISTF event, the Head Referee may substitute the referee and may report the referee to the Disciplinary Council.
 - (iv) Players with less than a year experience and/or of age categories will be considered as “Beginner Referees” and therefore not able to be sanctioned by the Head Referee. They will, however, be given a warning in cases 6.2(c)(ii).
- (d) **Duties of Head Referee**
 - (i) A player appointed as FISTF Head Referee shall be responsible for their knowledge of the current version of FISTF Sports Rules of Table Football. The current FISTF Sports Rules of Table Football are available on the FISTF website. FISTF approved translated versions may be available from MNAs.
 - (ii) For the duration of a FISTF event, the presence of at least one Head Referee in the event hall is mandatory. In case of Head Referee playing in a match, another appointed Head Referee must be available.
 - (iii) The Head Referee is required to:
 - (A) be fully focused on what happens in the tournament venue
 - (B) be ready to interrupt a match if player/coach/referee behaviour requires this
 - (C) assist with clarifications about the rules
 - (D) avoid any evaluative comment on players/matches
 - (E) be respectful to players/coaches/spectators
 - (F) check player equipment if required to do so by an officiating referee
 - (G) report a player/coach/referee to the Disciplinary Council if needed

6.3 FISTF Referee

- (a) **Definition of FISTF Referee**
 - (i) For every match during a FISTF event, there must be a referee to supervise all aspects of game refereeing according to the FISTF Sports Rules of Table Football. Their job is to:

- (A) evaluate the legality of players' equipment and defer to the Head Referee if there is uncertainty
 - (B) make all rule decisions during play
 - (C) decide in the event of problems regarding the behaviour of players
 - (D) submit reports to the Disciplinary Council about players and coaches, if required
- (b) **Appointing of FISTF Referee**
- (i) Referees will be managed by the Tournament Organiser with support from the Head Referee, as described in the **Tournament Organiser's Handbook**.
 - (ii) Referee name/club shall be affixed near each match during the competition.
- (c) **Rights of FISTF Referee**
- (i) During any match, the referee's decision is final and cannot be changed, except in cases where the referee may interrupt the match and ask the Head Referee for advice about rules.
 - (ii) Players are prohibited from asking the Head Referee for intervention. Only the match referee can ask for Head Referee intervention.
 - (iii) The following behaviour by players is strictly forbidden:
 - (A) Making game calls or refereeing actions themselves (e.g. "back", "foul", figure repositioning etc.)
 - (B) Changing referee decisions
 - (C) Criticising or influencing the referee's decisions
 - (D) The use of insulting or harmful comments towards the match referee
 - (E) Threatening or attempting to use force against the referee
 - (F) Stealing or damaging the match referee's equipment.
 - (iv) In (A), (B) or (C) cases listed at 6.3(c)(iii), the referee shall use the following procedure:
 - (A) At the first offence, the match referee shall warn the player that, should the player commit another offence, a yellow card will be issued.
 - (B) If another offence is committed, the match referee shall issue the player a yellow card and warn that, should the player commit another offence, an orange card will be issued.
 - (C) If a further offence is committed, the match referee shall issue the player an orange card (with spare goalkeeper removed) and warn that, should the player commit another offence, a red card will be issued.
 - (D) If a further offence is committed, the match referee shall issue the player a red card. In such a case, the game is terminated, and the match referee must immediately leave the table and inform a Head Referee and the Tournament Organiser about the situation. The offender is then disqualified and reported to the Disciplinary Council by the Head Referee or the Tournament Organiser.
 - (v) In (D), (E) or (F) cases listed at 6.3(c)(iii), at the first offence, the match referee shall give the player a red card. In such a case, the game is terminated, and the match referee must immediately leave the table and inform a Head

Referee or the Tournament Organiser about the situation. The offender is then disqualified and reported to the Disciplinary Council.

(A) If any of (D), (E) or (F) cases listed at 6.3(c)(iii) happens immediately before or after a match, the referee must inform a Head Referee or the Tournament Organiser about the situation.

(B) The offender is then disqualified and reported to the Disciplinary Council by the Head Referee or the Tournament Organiser.

(vi) The following behaviour by coaches is strictly forbidden:

(A) Disturbing players or referees

(B) Giving verbal instructions in an unreasonable manner

(C) Criticising or influencing the match referee's decisions

(D) The use of insulting or harmful comments towards match referees

(E) Threatening or attempting to use force against the referee

(F) Stealing or damaging the match referee's equipment

(vii) In (A), (B) or (C) cases listed at 6.3(c)(vi), any of the four referees shall use the following procedure:

(A) At the first offence, the match referee shall warn the coach that, should the coach commit another offence, the coach will be asked to leave the playing area. If another offence is committed, the match referee will ask the coach to leave the playing area. If the coach refuses to leave, the match referee must inform the Head Referee or the Tournament Organiser about the situation. The coach is then reported to the Disciplinary Council by the Head Referee or the Tournament Organiser.

(A) In (D), (E) or (F) cases listed in 6.3(c)(vi), at the first offence, any of the four referees shall inform a Head Referee or the Tournament Organiser about the situation. The coach is then reported to the Disciplinary Council by the Head Referee or the Tournament Organiser.

(B) If any of (D), (E) or (F) cases listed in 6.3(c)(vi) happens immediately before or after a match, any of the match referees must immediately inform a Head Referee or the Tournament Organiser about the situation. The coach is then reported to the Disciplinary Council by the Head Referee or the Tournament Organiser.

(viii) If the Head Referee finds that a match referee (individual or team) doesn't follow the procedures described above deliberately, their behaviour can be considered a deliberate breach of the present regulations, with the intent to change the normal course of a match. In this case, the referee (individual or team) may be reported to the Disciplinary Council by the Head Referee or the Tournament Organiser.

(d) Duties of FISTF Referee

(i) For any player it is mandatory to have a good knowledge of the current version of FISTF Sports Rules of Table Football. The current FISTF Sports Rules of Table Football are available on the FISTF website. FISTF approved translated versions may be available from MNAs.

(ii) The referee shall follow the Referee's Guide part of the FISTF Sports Rules.

- (iii) The referee is required to:
 - (A) Enforce FISTF Sports Rules during the match, including disabled player rules if applicable.
 - (B) Issue yellow, orange and red cards as appropriate.
 - (C) Ask the Head Referee for advice about Rules if needed.
 - (D) Be fully focused on the game.
 - (E) Be at the game table on time and during the full duration of the match.
 - (F) Avoid any evaluative comment on match/player.
 - (G) Be respectful to players/coaches/spectators.
 - (H) Compile and deliver the match report.
 - (I) Check each player's equipment.
 - (J) Keep match time with their own watch.
- (iv) A referee that repeatedly violates the behaviour listed at 6.3(d)(iii) may be reported to the Disciplinary Council by the Head Referee or the Tournament Organiser.
- (e) **Refusal to Referee**
 - (i) A player refusing to referee in an assigned round will be fined 25 Euros. For a team, the sanction shall be a fine of 100 Euros. The Head Referee or the Tournament Organiser shall also report the player or the team to the Disciplinary Council.
 - (ii) A player leaving the tournament without refereeing in the round following their elimination will be fined 25 Euros. For a team, the sanction shall be a fine of 100 Euros. The Head Referee or the Tournament Organiser shall also report the player or the team to the Disciplinary Council.
- (f) **Replacement of Referee**
 - (i) A referee (individual or team) may be substituted by the Head Referee or by the Competition Manager before starting a match if it appears that their nationality or club could be a conflict of interest with one of the players or teams in the match.
 - (ii) A referee (individual or team) may be substituted after receiving the second warning (see 6.2(c)(iii)), but ONLY if so requested by the Head Referee. The new referee (individual or team) will be appointed by the Head Referee.
 - (iii) A referee (individual or team) may be substituted before or during a match in case of health problems or other serious reasons. The Head Referee shall approve referee substitution and appoint the new referee (individual or team).
 - (iv) Except for cases 6.3(f)(i), 6.3(f)(ii) and 6.3(f)(iii), a referee (individual or team) cannot be substituted before or during a match, even if substitution is asked by the referee (individual or team).
 - (v) Referee (individual or team) substitution is applicable ONLY if a suitable replacing referee (individual or team) is available and accepts to referee.
 - (vi) Under no circumstances may an individual player or team request a change of referee.

7 Membership Fees & Levies

7.1 Table of the Membership Fees

Frequency	Amount
One-time registration fee	100 EUR

- Associations that have not organised an International Tournament in the previous season pay a 50 Euro membership fee for the upcoming season.
- The FISTF Board of Directors can exempt an MNA of the payment of the Membership Fees on a case-by-case basis, when the referred nation adheres to the FISTF Development Program (23). Once they have reached a Developed status, they must pay the 100 Euro fee.

- To help the development of the game outside of Europe, the FISTF Board has decided that there will be **no tournament levies for Satellites held outside Europe.**

7.3 Transfer fees

- There is no fee for the transfer of players.

7.4 Clubs fees

- Clubs do not have to pay a fee to be members of FISTF.

7.5 Players fees

- Players do not have to pay a transfer fee.

7.6 Payments to FISTF

- All payments regarding tournament fees and fines to clubs and players of a determined MNA must be done directly to FISTF by the MNA itself.

- (b) It is solely the responsibility of the MNA to receive the money from those organisers, clubs or players.
- (c) FISTF Finance Department will maintain a bank account for each MNA (20).

7.7 Payments of the Tournament Levies

- (a) The payment of the levies regarding a specific tournament must be paid within 30 days after the date of that tournament.
- (b) If the invoice is paid within 14 days, a discount of 25% will be granted. This amount is mentioned on the invoice.

7.8 Sanctions for Payment delays

- (a) For every payment not done within the determined deadline, a sanction fine will be applied on the following terms:
 - (i) For payments done on the **following 30 days** after the deadline, **15%** of the value in debt and all tournaments that are three months after the date when the payment was due will be cancelled.
 - (ii) Should this be paid, these tournaments which have been cancelled can be reactivated.

8 FISTF Age Categories

8.1 Tournaments are divided into different age categories

- (a) Players may normally play in only one category at each tournament, apart from the U12 (see below). Only if the organiser allows it, players can compete in two categories.

8.2 Definitions

For the season 2019/2020 the categories are as follows:

- (a) Open;
- (b) Veterans: players born before September 1st, 1973;
- (c) Under-19: players born from September 1st, 2000, until August 31st, 2004;
- (d) Under-15: players born from September 1st, 2004, until August 31st, 2007;
- (e) Under-12: players born from September 1st, 2007 onwards;
- (f) Women: female players only, of any age.

8.3 Dress Code

- (a) Definition:
 - (i) All individual players shall wear sports clothing such as their club or national team shirt, tracksuit, etc. Team players should wear their club colours, and sports shoes must also be worn (following the guidelines of individual venues). These guidelines are essential in promoting the image of the sport.
- (b) Infringement:
 - (i) The organiser must report this to the FISTF Sports Director. Any player who fails to observe this rule will be fined a token amount of 1 Euro or 3 Euros in case of a repeat offence.

- (ii) The players of a team must wear the colours of their club. In case of infringement, there will be a fine of 20 Euros or 50 Euros in case of a repeat offence.

8.4 Presentation of Equipment

- (a) Definition:
 - (i) Some players use teams in which some figures and bases are different from the rest of the team. Understandably, there will be breakages in a set of figures, but players must ensure that all their figures and bases are of the same design and colour. A player has the right to ask their opponent to change teams if this regulation is breached. There is no penalty for abusing this rule, but the referee must enforce it.
- (b) Infringement:
 - (i) The referee must ask the offending player to change their playing figures.

8.5 Late withdrawals or early departures of players from FISTF events

- (a) Players who:
 - (i) are not present at the scheduled beginning of any competition which they have committed themselves to attend, and who fail to give an early notice or to present a reasonable justification to the organiser of that competition within a reasonable time, or
 - (ii) leave the competition while they have already qualified for a next round of games, without playing their scheduled games (except for cases of huge delays of competition schedule)
 - (iii) or where a delay in competition may cause of missing the flight home on the same day (e.g. Saturday or Sunday). If players stay overnight and travel home the next day (e.g.: Monday), they shall stay at the event and play and show respect to fellow competitors;
- (b) Shall be penalised as follows:
 - (i) First time: 50 Euros fine and deduction of 50 world ranking points;
 - (ii) Second time (same season): 100 Euros fine and deduction of 100 world ranking points;
 - (iii) Third time: 150 Euros fine, deduction of 200 world ranking points and 6 months' suspension from any FISTF event.
 - (iv) Additionally, players who leave the competition without playing their scheduled games will be awarded no world ranking points from the specific competition.

8.6 Late withdrawals or early departures of club teams from FISTF events

- (a) Club teams which:
 - (i) are not present at the scheduled beginning of any competition which they have committed themselves to attend, and which fail to give an early notice or to present a reasonable justification to the organiser of that competition within a reasonable time, or
 - (ii) leave the competition while they have already qualified for a next round of games, without playing their scheduled games (except for cases of huge delays of competition schedule)

- (b) shall be penalised as follows:
 - (i) First time: 50 Euros fine and deduction of 50 world ranking points;
 - (ii) Second time (same season): 100 Euros fine and deduction of 100 world ranking points;
 - (iii) Third time: 150 Euros fine, deduction of 200 world ranking points and 6 months' suspension from any FISTF event.
 - (iv) Additionally, club teams which leave the competition without playing their scheduled games will be awarded no world ranking points from the specific competition.
- (c) Those tournament organisers who send a report with players who failed to attend without valid justification, shall be reimbursed the missing registration fee of those players by FISTF.

8.7 Special Rules for FISTF CL/EL and other Continental Competitions for Clubs

- (a) Club teams which:
 - (i) withdraw from a Continental Competition for Clubs after already having registered, and which fail to give an early notice of at least five weeks or to present a reasonable justification to the organiser of that competition within a reasonable time, or
 - (ii) leave the competition while they have already qualified for a next round of games (including placing qualification games), without playing their scheduled games (except for cases of huge delays of competition schedule)
- (b) Shall be penalised as follows:
 - (i) Withdrawal without giving an early notice of at least five weeks: 50 Euros
 - (ii) Withdrawal in the last 7 days before the competition: 100 Euros
 - (iii) Withdrawal in the last 48 hours before the scheduled start of the competition: 150 Euros, deduction of 100 world ranking points and suspension from the next Continental Competition for Clubs.
 - (iv) Additionally, club teams which leave the competition without playing their scheduled games will be awarded no world ranking points from the specific competition.

8.8 Special Rules for FISTF World Cup

- (a) National teams which:
 - (i) withdraw from a World Cup Teams event after already having registered, and which fail to give an early notice of at least two weeks or to present a reasonable justification to the organiser of that competition within a reasonable time, or
 - (ii) leave the competition while they have already qualified for a next round of games, without playing their scheduled games (except for cases of huge delays of competition schedule)
 - (iii) A delay in competition may cause of missing the flight home on the same day (e.g.: Saturday or Sunday). If players stay overnight and travel home the next day (e.g.: Monday), they shall stay at the event and play sportive and show respect,

- (b) Shall be penalised as follows:
 - (i) Withdrawal without giving an early notice of at least two weeks: 30 Euros per team
 - (ii) Withdrawal in the last 5 days before the competition: 50 Euros per team
 - (iii) Withdrawal in the last 48 hours before the scheduled start of the competition: 100 Euros per team and suspension of the withdrawn team from the next World Cup.
 - (iv) Additionally, National teams which leave the competition without playing their scheduled games will be awarded no world ranking points from the World Cup.
- (c) Players who:
 - (i) withdraw from a World Cup Individuals event after already having registered, and who fail to give an early notice of at least two weeks or to present a reasonable justification to the organiser of that competition within a reasonable time, or
 - (ii) leave the competition while they have already qualified for a next round of games, without playing their scheduled games (except for cases of huge delays of competition schedule)
- (d) shall be penalised as follows:
 - (i) Withdrawal without giving an early notice of at least two weeks: 15 Euros
 - (ii) Withdrawal in the last 5 days before the competition: 25 Euros
 - (iii) Withdrawal in the last 48 hours before the scheduled start of the competition: 50 Euros, deduction of 100 world ranking points and suspension from the next World Cup.
 - (iv) Additionally, players who leave the competition without playing their scheduled games will be awarded no world ranking points from the World Cup.

8.9 Special Rules for FISTF Continental Cup or Championship

- (a) National teams:
 - (i) The rules apply the same as for the World Cup.

9 FISTF Calendar

Considering the high number of tournaments played every year, some rules have been established.

9.1 Rules of construction of the Calendar

- (a) Only for Europe, the third weekend every month (except for June, July and August) should be free of Major, Grand Prix and International Open tournaments. All MNAs which have not sent their requests before the 15th of May, will have to send their request to FISTF before the tournament takes place.
- (b) An event over a weekend straddling two months will be considered as belonging to the starting month.
- (c) The deadlines for requesting an event are:
 - (i) Grand Prix - **4 months** before the date of the tournament
 - (ii) International Opens - **2 months** before the date of the tournament

- (iii) Satellite Tournaments - **1 month** before the date of the tournament.
- (d) Only Satellite Tournaments can be organised on a date that is a public holiday for a single country or a limited number of countries. Each MNA is entitled to organise only one Satellite on a public holiday for its country per season. This is included in the maximum number of Satellite events allowed.

9.2 Rules for the request of a FISTF Tournament

- (a) MNAs must send the dates for their FISTF tournaments for the following season to the FISTF Sports Director **before May 15th**.
- (b) All MNAs who send their dates before May 15 have the chance to have first choice for the weekend they requested for their Grand Prix. After that, the International Open of each MNA will be matched with all Grand Prix dates for the continent. If there is a conflict, the organiser of the International Open has to choose another date.
- (c) The tournaments are only officially confirmed if they are confirmed by the FISTF Sports Director and mentioned in the official FISTF calendar that is published in the FISTF newsletter or on the FISTF website and/or social media pages. FISTF is not liable for delayed or missing confirmations and each MNA has full responsibility for verification of requested tournaments acceptance. The first version of the calendar has to be published the latest **on the 20th of May**.
- (d) **After the 15th of May**, candidatures will not be accepted if they don't respect the deadline referred to in 9.1 (c) for the tournaments they request.
- (e) The FISTF Sports Director may move late applications according to the available dates.

9.3 Rules for the Major Grand Prix

- (a) A Major Grand Prix is requested **before April 30th**, through a separate process run by FISTF Sports Department, as described in 12.1.
- (b) A Major Grand Prix tournament must be the only tournament on the weekend in the relevant continent.
- (c) The Head Referee is appointed by the Sports Director of FISTF after the registration deadline and before the tournament. The Sports Director can nominate between one and three Head Referees. The tournament Organiser can, however, liaise with the Sports Director to change the appointed Head Referee(s) for specific reasons, which must be documented.
- (d) All Major Grand Prix MUST comply with certain rules:
 - (i) Prestigious Venue
 - (ii) Same surfaces and same goals on each table
 - (iii) Update website and social media activity during the tournament.

9.4 Rules for the Grand Prix

- (a) A Grand Prix must be requested by an MNA **before May 15th**.
- (b) Only one Grand Prix per continent is allowed on the same weekend. If several MNAs request the same weekend, the FISTF Sports Director will give priority to the MNA that already had the same weekend the season(s) before.
- (c) A Grand Prix may only be confirmed for an MNA that does not have any outstanding invoices payable to FISTF.

- (d) If an MNA does not request its Grand Prix **before the 15th of May**, the MNA loses the priority of the date the Grand Prix had the previous season.
- (e) The Grand Prix of an MNA **cannot** be divided in two separate events (individual Grand Prix and Open for teams and later a Grand Prix for teams and an individual Open)

9.5 Rules for the International Opens, Satellites

- (a) These tournaments can be requested by the MNA beginning on the **20th of May**.
- (b) In that case the MNA, which had the same date the season(s) before, will have the priority.
- (c) Satellites can be also organised on the 3rd weekend of the month.
- (d) The tournament organiser is the Head Referee of the tournament.
- (e) An updated website for each tournament is advised.

9.6 Combination of Tournaments in the same weekend

- (a) Two (2) or more tournaments are not allowed to be organised in the same country on the same weekend or public holiday.
- (b) Two (2) or more tournaments are allowed to be organised on the same weekend in different countries of the same continent, with the exception of a Major Grand Prix. Therefore, the following combinations will be accepted:
 - (i) Grand Prix + International Open
 - (ii) Golden Grand Prix + International Open
 - (iii) International Open + International Open
 - (iv) International Open + Satellite
 - (v) Satellite + Satellite
- (c) The FISTF World Cup weekend will be free of tournaments all over the world.
- (d) The FISTF CL/EL weekend will be free of tournaments in Europe.
- (e) Tournaments played in a single day of the weekend (only Saturday or Sunday) are considered as occupying the whole weekend. If an event take place for instance on a Sunday from such a WE (June 30th and July 1st), if the event is played on Sunday July 1st, it will be accounted in the July WR and not June WR.

10 FISTF World Cup

10.1 General Rules

- (a) The FISTF World Cup will be held biennially, in every even year (2020, 2022 etc).
- (b) Continental Championships should be held biennially in odd years (2021, 2023).
- (c) The maximum number of players in each category is as follows:
 - (i) Open: 64
 - (ii) Veterans: 64
 - (iii) Under-19: 32
 - (iv) Under-15: 32
 - (v) Under-12 32

- (vi) Women: 32

10.2 Selection of Players

- (a) MNAs may nominate a maximum of 2 players in each category, the national champion on the referred category usually being one of them.
- (b) Each MNA may also register a maximum of 2 substitute players in each category.
- (c) In addition, the FISTF World Ranking at the end of April will be used to select players as follows:
- (i) 8 **Open** category players (maximum 2 players per country);
 - (ii) 8 **Veteran** category players (maximum 2 players per country);
 - (iii) 8 **U19** category players (maximum 2 players per country);
 - (iv) 8 **U15** category players (maximum 2 players per country);
 - (v) 8 **U12** category players (maximum 2 players per country);
 - (vi) 8 **Women** players (maximum 2 players per country).
- (d) Consequently, an MNA can nominate up to 4 players in each category, including the substitute players plus 2 more players from this country who qualify through FISTF World Ranking (maximum 6 players in this case).
- (e) If the required number of players is not reached in a category as defined at 10.1(c), the priority for the selection of players is made according to the following criteria:
- (i) First substitute from a country that has no players selected by the World Ranking
 - (ii) First substitute from a country that has 1 player selected by the World Ranking
 - (iii) Second substitute from a country that has no players selected by the World Ranking
 - (iv) First substitute from a country that has 2 players selected by the World Ranking
 - (v) Second substitute from a country that has 1 player selected by the World Ranking
- (f) The World Ranking at the end of April will be used to determine the priorities for 10.2(e).
- (g) Special wild cards can be awarded by the FISTF Board of Directors, on a case-by-case basis,
- (i) to players coming from Nations that are not FISTF MNAs or;
 - (ii) to players registered by their Nation only for the team competition, even if the Nation's limits set in 10.2(d) are exceeded, in order to complete the maximum number of players in a category.
- (h) This system can guarantee that nations have a levelled number of players in the individual event and can also help in having more national teams.
- (i) Additionally, there will be National Team events in all categories, limited to those Nations that are Members of FISTF.
- (j) Teams eliminated in the first phase (groups) of the World Cup shall be reformed into a second 'Plate' event to give them more competition during the tournament.

11 Continental Championships

11.1 Definitions

- (a) As described in Article 6 of the FISTF Statutes, National Member Associations may group themselves according to Continental geographic areas into 'Confederations'.
- (b) Each Confederation may organise their own Continental championships.

11.2 Introduction

- (a) FISTF organises and controls the European continental championships, until the formalising of a European Confederation.
- (b) In Europe there are Individual and National Team Championships, and separate continental club competitions.
- (c) The FISTF Champions League and Europa League are separate events, while keeping the organisation of both allocated on a single weekend. Only European Clubs can participate. This structure simplifies event organisation and ensure critical success factors such as the following:
 - (i) A strong competition for CL which will always host the best European Table Football Clubs, while the EL will provide the chance for a balanced event for lower ranked participants.
 - (ii) Highly focused interest of Clubs to participate to an event already suited to their potential strength. This will increase competitive spirit from the first stage, leading to the sport success of both events.
 - (iii) Possibility for organisers to attract sponsors' attention in a single weekend, achieving better deals with service providers, which will ensure there will be no money loss and even help bringing profit from the organisation of the CL and EL.
 - (iv) A smooth and concentrated running of two independent events, without unbalanced or calculated matches, exhausting schedules, tiring delays or long idle periods.
- (d) A FISTF Super Cup, as a prestigious event is also introduced, played between the previous season's winners of CL and EL. The revised format defines two separate events where participating European Clubs are directly selected for the CL or the EL. Participating Clubs are selected via a list of predefined criteria, including FISTF WR ranking and a list of Applicants and Substitutes named by each European MNAs. Previous seasons winners are automatically qualified in the competition in which they were winners, as is the organising club's team. The way participating Clubs are selected and the structure of the tournaments, including the Super Cup, are described in detail in the following paragraphs. Qualification Clubs for CL are assigned first, then EL assignment follows.

11.3 Qualification of Champions League Clubs

- (a) A maximum of 24 teams will be allowed to participate in the FISTF CL competition each year. Only teams from Europe can qualify. A preliminary qualification procedure will decide which Clubs will have the right to take part in the CL group stage. Specifically, four categories are considered, in order:
 - (i) The first eight (8) European teams of FISTF WR (May edition) (Maximum 2 for each nation).

- (ii) Winner of the previous season's CL (1 team) and previous season's EL (1 team).
- (iii) The organiser (1 team).
- (iv) To determine the remaining qualified teams, FISTF has created a system to rank nations, based on the results of their clubs in the CL in the previous 5 years. (Appendix 3). This FISTF Coefficient Nation Ranking method will determine the number of qualified clubs, from 4 to 1 depending on the performances over the period. Respective MNAs nominate the nation's qualifying Clubs, in this way:
 - (A) Example 1 – A nation has 4 teams qualified. Two of these are qualified by the FISTF World Ranking, another one is qualified as the CL winner from the previous season. The national federation then has only one more place to fill, and names this team as Applicant A.
 - (B) Example 2 - A nation has one team qualified by the FISTF Coefficient Nation Ranking but has 2 teams that are qualified by ranking. Thus, there is no ability for the MNA to name any other team as Applicant A.
 - (C) Example 3 - A nation has 1 team qualified by the FISTF Coefficient Nation Ranking and does not have any teams that are qualified by FISTF World Ranking. The national federation can therefore name a team (normally the Champions of the national league) as Applicant A.
 - (D) Example 4 - A nation has 2 teams qualified by the FISTF Coefficient Nation Ranking and does not have any teams qualified by the FISTF World Ranking. The MNA can name one team (normally the Champions of the national league) as Applicant A, plus another team as Applicant B (normally the winner of the cup).
 - (E) Additionally, an MNA can also send a list of the nation's Substitute Clubs to FISTF. The nation's Substitutes list may contain any number of Clubs. The deadline for the sending of nominations is the end of June.
- (b) The definition of the Applicants, as described above, shall be determined by the following process.
 - (i) Top ranked teams in the MNA Club Championship
 - (A) Champion
 - (B) Runner-up
 - (C) Possible 3rd and 4th place, depending on number of qualifying places available based on Coefficient, and after teams qualified through 11.3(a).
 - (c) To be noted that an MNA can expand the list of the nation's Substitute Clubs after the deadline of June. The deadline for the update of the nation's Substitutes list is the end of August. However, any Clubs inserted into the list of Substitutes after the deadline of June take a lower priority than the Clubs already in the list. Substitute Clubs from nations that have not taken the 2 places to which they are entitled because they sent their nominations after the expiration of the deadline, are placed on top of the list of Substitutes.
 - (d) In case more than 24 teams apply for the CL competition, priority for participation is given, in order, to teams from categories I, II, III and then to teams from category IV in the order that is provided by the FISTF Coefficient Nation Ranking. In case the

number of 24 teams is not completed from the beginning or in case one or more Clubs cancel their participation, FISTF has the right to enlist Substitute Clubs in the empty CL places. Priority for selection is given to Substitute Clubs from nations higher in FISTF Coefficient Nation Ranking, until the number of 24 Clubs is completed.

- (e) Consequently, in case the number of 24 teams is still not completed, FISTF will start enlisting the Substitute Clubs, until the number of 24 Clubs is completed. This will be done by repeating the previous process.
- (f) It is emphasised that no more than 8 Clubs from the same nation can participate in the CL.

11.4 Qualification of Europa League Clubs

- (a) A maximum of 24 teams will be allowed to participate in the FISTF EL competition each year. Only teams from Europe can qualify. A preliminary qualification procedure will decide which Clubs will have the right to take part in the EL group stage. Specifically, three categories are considered, in order:
 - (i) The organiser (1 team).
 - (ii) FISTF has created a system to rank nations, based on the results of their clubs in the EL in the previous 5 years. (Attachment A). This FISTF Coefficient Nation Ranking method will determine the number of qualified clubs, from 4 to 1 depending on the performances over the period. Respective MNAs nominate the nation's qualifying Clubs, in this way:
 - (A) Example 1 – A nation has 4 teams qualified through the FISTF Coefficient Nation Ranking. However, one is already qualified as the winner of the EL the previous season, and another as organiser of the event, for the current season. The MNA can therefore select two more teams as Applicant EL A and Applicant EL B.
 - (B) Example 2 - A nation has 1 team qualified through the FISTF Coefficient Nation Ranking, but one club is already qualified as the winner of the EL in the previous season, and another as the organiser of the event, for the current season. The MNA therefore does not have any other places it can nominate as Applicant EL A.
 - (C) Example 3 - A nation has 1 team qualified through the FISTF Coefficient Nation Ranking and does not have any teams that have qualified through either 11.4 (a) (i) or (ii). The MNA can therefore name a team as Applicant EL A.
 - (D) Example 4 - A nation has 2 teams qualified through the FISTF Coefficient Nation Ranking and does not have any teams that have qualified through either 11.4 (a) (i) or (ii). The MNA can name a team as Applicant EL A plus another team as Applicant EL B.
 - (E) Additionally, an MNA can also send a list of the nation's Substitute Clubs to FISTF. The nation's Substitutes list may contain any number of Clubs. The deadline for the sending of nominations is the end of June.
- (b) The definition of the Applicants, as described above, shall be determined by the following process.
 - (i) 2nd ranked team in the MNA Club Championship.

- (A) Possible 3rd and 4th place, depending on number of qualifying places available based on Coefficient, and after teams qualified through 11.3(a).
 - (B) MNA Club Cup
 - (I) Cup Winner
 - (II) Cup Finalist (Runner-Up) in case of a national double
 - (C) Possible 5th and 6th place in MNA Club Championship, depending on number of qualifying places available based on Coefficient, and after teams qualified through 11.3(a).
- (c) In case more than 24 teams apply for the EL competition, priority for participation is given, in order, to teams from categories I, II and then to teams from category III in the order that is provided by the FISTF Coefficient Nation Ranking.
 - (d) In case the number of 24 teams is not completed from the beginning or in case one or more Clubs cancel their participation, FISTF has the right to enlist Substitute Clubs in the empty EL places. Priority for selection is given to Substitute Clubs higher in FISTF Coefficient Nation Ranking, until the number of 24 Clubs is completed.
 - (e) Consequently, in case the number of 24 teams is still not completed, FISTF will start enlisting the Substitute Clubs, until the number of 24 Clubs is completed. This will be done by repeating the previous process.
 - (f) It is emphasised that no more than 8 Clubs from the same nation can participate in the EL.

11.5 European Individual Championships

- (a) Restrictions on the numbers of players for the European Championships currently apply.
- (b) The maximum number of players in each category is as follows:
 - (i) Open: 48
 - (ii) Veterans: 48
 - (iii) Under-19: 32
 - (iv) Under-15: 32
 - (v) Under-12: 32
 - (vi) Women: 32

11.6 European National Team Championships

- (a) Additionally, there will be National Team events in all categories, limited to those Nations that are European Members of FISTF.
- (b) The Individual and Team events will be held on the same weekend in the same venue.

11.7 Non-European Continental Championships

- (a) Continental Championships outside Europe can be organised under the auspices of the relevant Continental Confederation. Each Confederation's regulations can be included in the **FISTF Handbook**.

11.8 Confederation of Asian Sports Table Football Associations

- (a) The Asian Cup of Table Football is organised by the three foundation members: Singapore, Japan and Australia, on a rotational biennial basis, in years alternating with the FISTF World Cup.
- (b) As other countries become full members of FISTF and CASTFA, they shall have the opportunity to stage the Asian Cup.
- (c) The Host of the Asian Cup has the right to organise categories, respecting the FISTF categories and regulations.
- (d) All categories are open to all players registered with any nation in the Asian region, with no restriction on the number of entries. All players must be registered with FISTF. (See 5.3(a))
- (e) In the Club Team event, A, B, C etc. teams may enter from one club.
- (f) In the National Team event, A and B team events, and Youth and Women events may be organised.

11.9 Confederation of South American Sports Table Football Associations

- (a) South American Table football is organised by the two members: Brazil and Argentina.
- (b) The South American Championship is staged on a rotational annual basis, in the weekend close to the 12 October Holiday.
- (c) As other countries become full members of FISTF and CSASTFA, they shall have the opportunity to stage the South American Championship.
- (d) The Host of the South American Championship has the right to organise categories, respecting the FISTF categories and regulations but also will organise Button Football categories.
- (e) All categories are open to all players registered with any nation in the South America region, with no restriction on the number of entries. All players must be registered with FISTF. (See 5.3(a)) (e).
- (f) In the National Team event, team events, and Youth and Women events may be organised.

11.10 FISTF Youth Champions League

- (a) Youth representatives of all the clubs affiliated to FISTF can take part in the Youth Champions League for teams.
- (b) Each club can register more than one team.
- (c) The club teams will be composed of at least three players, belonging to the U12, U15 or U19 categories.
- (d) Each team can play only one U19 youth player, even if more than one U19 player may be presented in the registered club team list. If U19 players are present in both teams, then these two U19 players must play each other.
- (e) Example:
 - (i) Team X vs. Team Y
 - (ii) U15 versus U19. U19 versus U19. U15 versus U15.
 - (iii) U12 versus U15. U12 versus U15. U12 versus U15
 - (iv) U15 versus U12. U15 versus U15. U12 versus U12.

- (f) If a club enters more than one team, the first team shall be designated as 'A', the second as 'B' and so on,
- (g) At the time of registration, each club will provide a list of its teams, and the players designated to those teams. They cannot be changed to other teams during the tournament.
- (h) Players from the same club cannot referee their club mates.
- (i) Youth teams can also be entered into the Youth Champions League if they consist of youth players of different clubs that do not have their own youth team, but belong to the same region (County-UK, Kanton-CH, Bundesland-AUT, etc) or nation, that may join together to form a new youth team in the interest of sports development.
- (j) However, clubs are encouraged to create their own youth teams and not regional teams.
- (k) Youth players of different regions are not permitted in the same team. The FISTF Sports Director will decide on this in the case of a lack of clarity.
- (l) Such a regional team will be designated as 'Normandy Youth-FRA' or Nordjylland Youth-DAN.
- (m) In case of a special 'Youth Development Centre' (such as the STFC Champ 22 in Vienna) then such a team may participate under such a banner for a region. However, all players must then live officially in the same region. (see (k) above).
- (n) The official residential address of all players is required to confirm registration.
- (o) Depending on the number of club teams registered, the draw will be made in such a way to provide the most matches possible: e.g. groups of 4, 5 or 6.
- (p) After the group phase (round robin system) a direct elimination system will be used, with the creation of two youth tournaments.
 - (i) Youth Champions League (YLC), will be played with the qualified teams from the group stage
 - (ii) Youth Star League (YSL), will be played by the eliminated teams from the group stage.
- (q) Before the beginning of the event, each club team will present a list of their players containing the names of the team captain and any accompanying team manager (responsible person) to the organiser (Host Club) and FISTF official.
- (r) The captain will be responsible for delivering the list of players summoned for each game, the draw and the deployment of the club team.
- (s) During the draw and during the match, only the 3 players indicated in the list of each team and the referees of the match are allowed to stay within the match sector.
- (t) Each match assignment will follow the normal FISTF process, with these exceptions:
 - (i) If only one team plays with an U19, they will have to play with the first U15, indicated in the list.
 - (ii) If both teams have an U19, they must play each other.
- (u) In the interests of the development of youth players, FISTF has imposed limits on the goal difference in each match. (Rule of 5 goal difference)
- (v) In each match, only the goals scored by a player in a single match up to 5 goals will be counted. The additional goal difference will not be taken into consideration. All the matches with a result superior to 5-0, will be considered 5-0.

- (i) If a match ends 7-2, the difference is 5 goals, so all goals scored will be counted.
- (ii) If a match ends 8-1, the result will be reduced to 6-1 in case of a draw between the clubs, and not to 5-0.
- (iii) In case the playing clubs draw 1-1 in their match in a knock-out-stage, the goal difference will count immediately after the regular time of 2x15minutes.

Progresses to a shootout on all three tables

- (w) At the end of the first half a team can replace one player. The only limitation is that an U19 player can only replace another U19 player.
- (x) Registration for the event will be free. To avoid transfers and a wild market of the young players, only the players registered in the previous season with the same club can play the Youth Champions League. Youth players that make an inscription in a club team for the first time can play freely.
- (y) Match Procedure
 - (i) For each team match, the team's captain shall present a maximum of 4 players in the playing area. Maximum two of them are U19. In that case, one of them will be the reserve player.
 - (ii) The captains will write the order of their players on the match protocol to the referee.
 - (iii) Player number 1 of each team will play against each other.
 - (iv) Player number 2 will play against each other
 - (v) Player number 3 will play against each other.
 - (vi) If a team has one U19, they must always be placed as number 1.
 - (vii) At half time, both captains have the opportunity to substitute one of their 3 players. The referee shall be notified of this substitution. The reserve player takes over any sanctioned cards (Yellow or orange) of the player they replaced.
 - (viii) If the reserve is U19, they may replace only the other U19 player.
- (z) Each FISTF Nation or club may send anytime a candidature to the FISTF Board of Directors to host the Youth Champions League. Candidates should submit **Form F04** to their MNA for submission to FISTF.

12 FISTF Tournaments

12.1 Major Grand Prix

(a) **Definition:**

- (i) Each season, the five best Grand Prix tournaments around the world are allotted the status of Major Grand Prix. These tournaments are considered the

most prestigious outside of the World Cup and Continental Championships. The allotment of all five Major Grand Prix will be reconsidered each season.

(b) **System of selection:**

- (i) The right to organise a Major will be given to those tournaments considered to be the best choices for the next season only, according to certain weighted criteria that FISTF has defined.
- (ii) The idea is to form a list of “candidate” tournaments every year and let FISTF criteria decide the best five to be named Majors for the next season. Every year, the list of “candidates” shall be populated by a maximum of two tournaments per nation, including any event from the same country already among the five current Majors, which will be named exclusively by the respective MNAs, provided that candidate events from the same country must be at least 50 Km away from each other.
- (iii) Nominations will be fixed on April the 30th every year, so that a two-week period will be allowed to FISTF Sports Department in order to calculate the weighted points and announce the five Majors long enough before May 15th, which is the deadline for the MNAs to submit Grand Prix applications to FISTF. The organisers of the five tournaments selected to be next season’s Majors will, until May 15th, must set the date of the event, so that FISTF Calendar is updated in time.
- (iv) The criteria for the selection of Majors will be the following:
 - (A) Total number of individual participants in all categories the last time the event was organised (*)
 - (B) Total number of categories played (Open, Veterans, U19 etc.) the last time the event was organised (*)
 - (C) Total number of foreign players in all categories the last time the event was organised (*)
 - (D) Total number of top-10 ranked players in all categories the last time the event was organised (*)
 - (E) Total number of events (International Open, Grand Prix and Major Grand Prix) organised in the country of the candidate event during current season.
 - (F) An international airport in a short distance from the venue of the event
 - (G) An overall evaluation judging the quality of venue, condition & number of tables, media coverage, organisers’ spirit of co-operation with FISTF, decided by FISTF BoD.

() If the event has not been held before the third weekend of April of the current season, the statistics of last year’s version of the event will be used instead.*

- (v) Each criterion will be given 1 - 5 points, depending on the level of satisfaction of the specific criterion. Pre-defined ranges of values will delineate the level of satisfaction for each criterion. So, a total of $5 * 7 = 35$ points will be the best possible mark for a candidate. The exact ranges of values for each selection criterion mentioned above were defined and published by FISTF Sports Department on April 22nd, 2013.
- (vi) The large number of selection criteria ensures that no manipulation will be possible. In case two or more events gather exactly the same number of points

and as a result it is not possible to decide the winner, the Major status will be awarded to the event with more points in criterion 1, then criterion 2, then criterion 3 and so on.

- (vii) The five tournaments in the list of candidates collecting the most points will be named Majors for next season. No more than 2 tournaments from the same country will be allowed to have a Major status during the same season.

(c) **Deadline for the MNAs to send candidacies:**

- (i) As mentioned above, any MNA that names tournaments as their candidate for a Major for the following season will have to send their application before April 30, midnight, stating the name of the event and its distance from an international airport and giving any additional information related to the seventh criterion (see above).
- (ii) All five current Majors must be included by their respective MNAs in next season's candidates list. A current Major not included in the list proposed by its MNA will not be considered among the candidates. Only two nominations are allowed for each MNA.

(d) **Tournament System:**

- (i) It is mandatory to have both events, Individual and Teams, in a Major Grand Prix.
- (ii) The first round of the tournament must be a group stage with a minimum of 4 players per group, in which all players must participate. Groups with a bigger number of players are accepted.
- (iii) The organiser must inform FISTF about the structure of the tournament's groups one month before its date.
- (iv) Compliance to the sports regulations defined in the **FISTF Tournament Organisers Handbook** is mandatory.

12.2 International Grand Prix

(a) **Definition:**

- (i) An International Grand Prix should be the best International tournament organised in a country in terms of quality and total number of players, not considering a Major Grand Prix, organised by the same MNA.
- (ii) Only high-quality international tournaments will be accepted at an International Grand Prix.

(b) **Specific competition rules:**

- (i) Each MNA of FISTF is entitled to organise one (1) Grand Prix per season.
- (ii) At least 24 players must take part for world ranking points to be awarded. The FISTF Sports Director may take the decision to allow the downgrading of an International Grand Prix to an International Open if the number of attending players is not equal to or above 24 and there are no more than 3 players from the Top 100 in the latest available World Ranking.

(c) **Tournament System:**

- (i) It is mandatory to have both events, Individual and Teams, at an International Grand Prix.

- (ii) The first round of the tournament must be a group stage with a minimum of 3 players per group, in which all players must participate. Groups with a bigger number of players are accepted.
- (iii) The organiser must inform FISTF about the structure of the tournament's groups one month before its date. Compliance to the sports regulations defined in the **FISTF Tournament Organisers Handbook** is mandatory.

12.3 FISTF Golden Grand Prix

(a) **Definition:**

- (i) A FISTF Golden Grand Prix is a special class of Grand Prix, awarded to an MNA for one of its clubs or events which has reached a particular milestone.
- (ii) These Golden Grand Prix are for events which have reached 20, 25, 30, 40 etc. consecutive editions of the event, or existence of the club.
- (iii) Only high-quality international tournaments will be accepted as a Golden Grand Prix.

(b) **Specific competition rules:**

- (i) Each MNA of FISTF is entitled to organise one Golden Grand Prix per season.
- (ii) At least 24 players must take part for world ranking points to be awarded. The FISTF Sports Director may take the decision to allow the downgrading of a Golden Grand Prix to an International Open for the purposes of ranking points if the number of attending players is not equal to or above 24 and there are no more than 3 players from the Top 100 in the latest available World Ranking.

(c) **Tournament System:**

- (i) It is mandatory to have both events, Individual and Teams, at a Golden Grand Prix.
- (ii) The first round of the tournament has to be a group stage with a minimum of 3 players per group, in which all players must participate. Groups with a bigger number of players are accepted.
- (iii) The organiser must inform FISTF about the structure of the tournament's groups one month before its date.
- (iv) The MNA applying for the Golden Grand Prix must produce documentary evidence supporting the candidature.
- (v) Compliance to the sports regulations defined in the **FISTF Tournament Organisers Handbook** is mandatory.

12.4 International Opens

(a) **Definition:**

- (i) An International Open is the most commonly organised International tournament.

(b) **Specific competition rules:**

- (i) Each MNA of FISTF is entitled to organise two (2) International Opens per season.
- (ii) AN MNA of FISTF with more than 200 licenced players in the country (Paid members) is entitled to three (3) International Opens per season.
- (iii) Each MNA must submit its preferred date(s) to the FISTF Sports Director.

- (iv) At least 16 players must take part for world ranking points to be awarded. The FISTF Sports Director may take the decision to allow the downgrading of an International Open to a Satellite if the number of attending players is not equal to or above 8 and there are no more than 3 players from the Top 100 in the latest available World Ranking.

(c) **Tournament System:**

- (i) The first round of the tournament has to be a group stage with a minimum of 3 players per group, in which all players must participate. Groups with a bigger number of players are accepted.
- (ii) The organiser must inform FISTF which will be the structure of the tournament's groups one month before its date.
- (iii) Compliance to the sports regulations defined in the **FISTF Tournament Organisers Handbook** is mandatory.

12.5 Satellites

(a) **Definition:**

- (i) A Satellite is an International tournament reserved for players who are not highly ranked in the FISTF lists. However, all FISTF standards must be respected.

(b) **Specific competition rules:**

- (i) Each MNA of FISTF is entitled to organise three (3) **Satellites** per season.
- (ii) At least 8 players must take part for world ranking points to be awarded.
- (iii) Only players ranked outside the top 100 in the World Ranking may take part in this competition.
- (iv) In a Satellite, all players should compete in the Open category, although other categories are allowed.
- (v) Players competing in other Categories (i.e., U19, Veterans, etc) are restricted to those ranked outside the top 20 in the World Ranking.

(c) **Tournament System:**

- (i) The first round of the tournament has to be a group stage with a minimum of 3 players per group, in which all players must participate. Groups with a larger number of players are accepted.
- (ii) The organiser must inform FISTF of the structure of the tournament's groups one month before its date.
- (iii) Compliance to the sports regulations defined in the **FISTF Tournament Organisers Handbook** is mandatory.

(d) **Teams Competition:**

- (i) Satellite for teams can be organised.
- (ii) Only clubs which are not in the Top 20 of the Teams Ranking can take part.
- (iii) Minimum of 4 teams have to take part for world ranking points to be awarded.
- (iv) A club from the Top 20 can register its B-team providing:
 - (A) The B-team is not in the world's Top 20, and;

- (B) The players taking part are not in the Top 100 in the Open world ranking or in the Top 20 of Veterans category.
- (e) **Wild-cards:**
 - (i) The organisers may invite a maximum of 3 players who don't qualify under the terms of point 12.4(b).
 - (ii) Players who receive a Wild card cannot be in the top 50 of the latest Open world ranking.
 - (iii) For Satellites organised outside Europe, there is no restriction on the qualification of players for the event.

13 Experimental tournaments

13.1 Definition

- (a) Experimental tournaments (**ETs**) are not a class, but rather tournaments aimed to test new rules, formats or equipment, in exemption to the existing regulations.

13.2 Parameters

- (a) Only Satellites can be ETs.
- (b) ETs fall in four categories depending on the nature of the experimentation:
 - (i) The game rules;
 - (ii) Organisational aspects (for example the suppression of the sudden death extra time);
 - (iii) The format (e.g. the Swiss formula);
 - (iv) The game equipment. This category is more suited for achieving sponsorships with equipment producers.
- (c) Organisers of a certain event may ask FISTF to stage an **ET** at least 60 days in advance. They must declare the specific innovation(s) to be experimented. Typically, only one kind of innovation per tournament is permitted, unless the experiment involves several connected innovations of minor import. The Sport Director has the authority to decide whether to grant or refuse the request.

13.3 Duties and responsibilities of the organisers

- (a) The tournament's experimental nature must be clearly stated on the tournament website, on posters and on each form of announcement/advertisement. In addition, the organisers must clearly and carefully detail category, nature and scope of the innovation.
- (b) Before the start of the competition (or before the start of the consolation tournament), an adequate amount of time must be committed to briefing players on the nature of the experiment and the proposed changes. In the case of category I ETs, it is strongly recommended that the organisers distribute leaflets detailing the rules changes and organise displays on the pitches, to ensure everyone understands the changes.
- (c) Category I ETs shall use referees. These are players familiar with the innovation(s). The organisers must appoint enough referees so that one of them is always on hand (i.e. not engaged in play or the organisation) to clarify doubtful situations.
- (d) Organisers are required to write a report on the outcome of the experiment.

13.4 FISTF duties and responsibilities

- (a) ETs are exempt from all FISTF fees.
- (b) The experimental nature of the event shall be noted on the official FISTF calendar.

14 Friendly International Matches

14.1 Definitions

- (a) These cover matches between two international teams.
- (b) The controls are performed by FISTF inspectors. These are volunteers appointed by FISTF.

14.2 Specific competition rules

- (a) There can be 2 official matches between 2 nations possible per season. See also 15 International Team Tournaments.
- (b) Matches can only be staged between MNAs.
- (c) If the game takes place at an international tournament, the organiser of this tournament must be informed too.
- (d) If both MNAs confirm the scheduling of an official game, but one nation fails to attend, the game will be awarded as a 4-0 forfeit.
- (e) Official friendly national games must be played with referees.
- (f) After the game a **Form F19: International Friendly Form** with the results and the referees must be sent to FISTF for the result to be included in the FISTF Nations ranking.

14.3 Requirements for requesting friendly matches

- (a) International friendly matches must be requested by both participating national federations 4 weeks before the planned date for the matches, with the FISTF Sports Department and confirmed by the FISTF General Secretary department.
- (b) For any international friendly match to be recognised by FISTF, part 1 must be complied with fully by all involved MNAs.

15 International Team Tournaments

15.1 Definitions

- (a) FISTF permits the organisation of tournaments involving national teams, so that emerging MNAs and their players experience “internationals” and gain ‘caps’ within international matches.
- (b) These events may be used to draw Media attention when Internationals are played, such as the “British Home Nations” or regional matches like in Iberia, Central Europe or Scandinavian region. This can boost every region in the world, like local or regional rivalry.
- (c) World ranking points. There will be an additional percentage of World Ranking Points awarded as in normal friendly matches. (17.8)
 - (i) 30% more points for a 3-country event than for a simple friendly international
 - (ii) 40% more points for a 4-country event than for a simple friendly international

- (iii) 50% more points for a 5-country event than for a simple friendly international
- (d) Such events can only be staged once a year.
- (e) Such tournaments can only be staged between MNAs.
- (f) If the games take place at an international tournament, the organiser of this tournament has to be informed too.
- (g) If the MNAs confirm the scheduling of an official game, but one nation fails to attend, the game will be awarded as a 4-0 forfeit.
- (h) Matches as these tournaments must be played with referees.
- (i) After the game a **Form F19T: International Tournament Form** with the results and the referees must be sent to FISTF for the result to be included in the FISTF Nations ranking.

16 Consolation tournament

16.1 Definitions

- (a) Organisers of all tournaments are advised to organise consolation tournaments for the players in each category out in the first round. This rule is NOT mandatory.

16.2 Specific competition rules

- (a) All matches must have referees.

Section 3 Rankings

17 FISTF World Ranking

17.1 Rules

- (a) For every FISTF tournament, world rankings points are awarded.
- (b) When compiling the result and the ranking of one month, points from the previous 12 months are divided by 2 and points from the previous 24 months are simply removed (already divided by 2 of course after 1 year). Proposed new, clearer text: When compiling results and rankings of any one month, points from the previous 12 months are counted in full, points from between 12- and 24-months prior are halved and points from more than 24 months prior are removed.
- (c) If a tournament is played over 2 days of different months (e.g.: September 30 & October 1), the tournament will count for the first month possible (e.g.: September)

17.2 Tables

- (a) Hereunder, the table of the points awarded.

17.8 Friendly International Matches

- (a) Award Points for the FISTF Nations Ranking:
- (i) Victory: 20 points
 - (ii) Draw: 8 points
 - (iii) Loss: 0 points
- (b) Bonus points for the FISTF Nations Ranking:
- (i) 10 points for beating the World's number 1 team
 - (ii) 6 points for beating the World's number 2 team 3 points for beating the World's number 3 team.

Section 4 Standardisation

18 Controls on the game equipment and event locations

18.1 Definition

- (a) Regular controls over the equipment and the locations are an essential feature of any sporting activity. They are managed according to the **FISTF Homologation Handbook** that includes the list of all FISTF approved equipment. The controls on the players' equipment (18.2) are implemented in every FISTF tournament; controls on the organisers' equipment and the event locations (18.3) are intermittently carried out by FISTF officials. Finally, in certain high-level tournaments the organisers must provide information about the pitches and goals they will use in the event (18.3).

18.2 Controls on the players' equipment

- (a) The controls are handled by delegates appointed by the event organisers. They are implemented mainly through the FISTF Measuring Tool, following the instructions of the "FISTF Measuring Tool – Directions of use" document. The equipment checked includes bases, balls and goalkeepers. Figures only come into consideration insomuch as the height of base + figure is concerned.
- (b) The organisers must:
 - (i) Hold available at least two pieces of the FISTF Measuring Tool.
 - (ii) Hold available a copy of the **FISTF Homologation Handbook**.
 - (iii) Hold available a copy of the FISTF Measuring Tool – Directions of use.
 - (iv) Appoint one or more delegate(s) to carry out the controls.
 - (v) Send a report to FISTF with the registered occurrences.
- (c) For each event day (this usually means once for the team event and once for the individual competition), the delegate(s) check several game tables equal to 15% (rounded up) the number of the players participating to the tournament. The tables to be checked are chosen at random. The checks are performed before the start of the matches, after the players have deployed their teams and goalkeepers. Moreover, checks must be run in at least two separate batches performed at different times. If the tournament is subdivided in categories, at least one table in each category must be checked.
- (d) For each table the delegate(s) checks the ball, the goalkeeper and one of the bases (selected at random) used by each player, taking advantage of the FISTF Measuring Tool.
 - (i) In the case of the base the delegate checks:
 - (A) the minimum height of base + figure;
 - (B) the maximum base diameter;
 - (ii) In the case of the goalkeeper the delegate checks:
 - (A) that the figure passes through the opening smoothly, while holding the rod in a perfectly horizontal position;
 - (B) the thickness of the goalkeeper figure;
 - (C) the straightness of the rod. Only a slight angle at the junction point between the rod and the handle is allowed;

- (D) The rod's width;
- (E) The lengths of the rod and the handle.
- (iii) In the case of the ball, the delegate checks its diameter and that it rolls straight.
- (e) A player suspecting the opponent to be using illicit equipment may alert the referee either before the match starts or during the interval. The referee determines if the charge is plausible. If so, the Head Referee(s) and/or the organisers shall be alerted. Checks requested by players must be noted in the pertinent form, but they do not count toward the minimum number of controls that must be performed each day.
- (f) If a referee believes a player is using illicit equipment, they proceed in the same way and the same points in time (before the match starts or during the interval).
- (g) Disagreements on the regularity of a player's equipment are adjudicated by the head referee(s).
- (h) **Sanctions:**
 - (i) Upon being confirmed to be using irregular equipment, a player must immediately surrender it to the organisers, who shall hold it in custody as long as the player remains in play. No attempt to rectify the item(s) on the spot is allowed. Repeat of the infringement or refusal to surrender it will lead to the player's immediate disqualification from the tournament (both days).

18.3 Controls on the organisers' equipment and the event locations

- (a) The controls are performed by FISTF inspectors. These are volunteers appointed by FISTF.
- (b) Inspectors for a certain event cannot be selected among the members of the organisers' team. Inspectors will preferably be chosen among foreign players (in respect to the country hosting the competition).
- (c) FISTF will present inspectors with any information provided by the organisers about the equipment used in the event.
- (d) The inspector checks:
 - (i) The pitches and goals to see if their brands correspond to the organiser's indications;
 - (ii) the tables and pitches, paying attention to
 - (A) the balance of the table (the surface must be neither bended nor inclined); and
 - (B) the uniformity of the cloth (there must be no bubbles or waves especially in the playing area);
 - (iii) the functional and aesthetic value of the equipment (newness, cleanness, lack of wear);
 - (iv) the merits of the facilities arranged by the organisers, including:
 - (A) the game hall
 - (B) the positioning of tables and fences;
 - (C) the bar / restaurant;
 - (D) The toilets.

- (e) Optionally, the inspector may assess additional features, like the respect of the time schedule, of FISTF tournament regulations, players wearing sports uniforms, and the suitability of the official hotel accommodation, if applicable.
- (f) **Sanctions for false statements rendered by the organisers:**
 - (i) False statements rendered by the organisers shall be sanctioned with a fine between 20 EUR and 100 EUR, depending on the severity of the situation.

19 Decisions by the FISTF Board

19.1 Definitions

- (a) It is solely at the discretion of the FISTF Board of Directors to take a decision about any situation not described or not well clarified by the present regulations.
- (b) In the case of any doubt, the decision of the FISTF Board will be accepted as valid. The Board has the right to take such decisions to an ad hoc vote of the member associations for validation.
- (c) Any decision taken by the FISTF Board of Directors/Members within this context will prevail for future similar situations.
- (d) Only the FISTF AGM or Congress has the authority to override the decisions of the FISTF Board of Directors.

21 Financial plan – expenditure

Several issues are anticipated about expenditure:

21.1 FISTF organisation and administration

- (a) The members of the Board of Directors and any committees may present a claim for payment of expenses to the Board of Directors. These expenses can only be for the purpose of attending FISTF sporting events. However, the BoD shall limit the payment to the Director whose place of residence is closest to the venue for the above events. Only one Director shall be entitled to claim expenses per event. If the Director takes part in the event as a player, then the Director shall be ineligible to make a claim on expenses. It shall then be at the discretion of the BoD to allow another Director to claim expenses.
- (b) The exception to this rule shall be for the FISTF annual general meeting or the Congress. For these, each Director, if they so wish, may make a claim of 20 € per day. This shall be limited to one day before the AGM, and the two days of the World Cup.
- (c) Each Director wishing to make a claim, must provide an expense claim form (**Form F05**) at least a week before the planned expenses, and have this approved by the BoD. The BoD will then instruct the Finance Director to authorise payment on receipt of invoices/proof of expenses/travel.

21.2 Development assistance

- (a) FISTF will devote part of its budget to the development of sports table football. This assistance will be in practice:
 - (i) Reductions in the fees paid by the MNAs;
 - (ii) The purchase and provision of equipment for the smaller associations.
 - (iii) Donation to event organisers for the running of events.

21.3 Allowances

- (a) Miscellaneous awards - FISTF may contribute to MNAs whose clubs and players have contributed towards the development of sports table football.

Section 6 Marketing, Promotion and Communication Regulations

22 Marketing, Promotion and Communication Regulations

22.1 Definitions

- (a) The Marketing, Promotion and Communication Department is responsible for the aesthetic, technical and practical part: website, FISTF blog, news, Facebook, Twitter, Instagram and other means of generating publicity for FISTF and Sports Table Football.
- (b) The Marketing, Promotion and Communication department shall be responsible for relations with the international media and with the communications departments of national associations, so that 'SPORT TABLE FOOTBALL' will be promoted as a Sport.

This is necessary to gain sponsors for all events world wide

22.2 Communication action points

- (a) There are various issues to develop:
 - (i) Membership administration:
 - (A) It is the general secretary's responsibility to maintain a list of registered players and clubs of FISTF in conjunction with the MNAs and tournament organisers.
 - (ii) Rules of the game:
 - (A) The rules of the game must be available in French and English, the two official languages used by FISTF. The MNAs must arrange translations of the rules into their own national languages. FISTF shall monitor this effort.
 - (iii) FISTF Sports News is the FISTF e-newsletter;
 - (iv) Promotion, public relations and sponsorship:

22.3 Publications

- (a) Sports table football literature
 - (i) Various publicity leaflets about sports table football will be produced for the attention of the media, the public (for distribution at events) and partners.

22.4 Marketing

- (a) This department shall be responsible for:
 - (i) The General aesthetic (clothing, places, events, etc.).
 - (ii) Rules and requirements for FISTF tournaments.
 - (iii) Homologation Licensing.
 - (iv) The Design and Style Guide of FISTF and all the international events, sponsors, relation with producers and distributors of equipment.
 - (v) It will offer to the producers and distributors a collaboration package.



22.5 Products Homologation

- (a) This section is available in two separate specific documents “**FISTF Homologation Guide**”, and “**FISTF Homologation Handbook**”, released by the Sports Department.

Section 7 Development

23 FISTF Development Program

- (a) FISTF will issue programs for the development of sports table football on a national and/or regional level worldwide.
- (b) These programs shall be established between FISTF and an MNA or a club.
- (c) FISTF partners can be added to the program on a case-by-case basis.
- (d) A protocol shall be signed between all involved parts in order to define duties and rights of each part.
- (e) There are no restrictions on which MNAs and clubs can take part in the FISTF Development Program.

24 Training Centres

24.1 Goals of the centres

- (a) To give local, national and foreign players a place to meet, play and communicate with other players.
- (b) To have a place to train your local and/or national team for international competitions.
- (c) To build the sporting image of Sports Table Football.
- (d) To support national federations in developing Sports Table Football in their country.

24.2 Centre characteristics

- (a) There must be good quality FISTF Pitches.
- (b) The centre should be open at least 1 day a week for a minimum of 3 hours each time.
- (c) The centre must be set up in a clean and non-smoking environment.

24.3 What the Centre gets in return from FISTF

- (a) Official title as “FISTF Training Centre”.
- (b) A place on the FISTF website listing all the Centres with their locations and information, which is also a way to display the projects and organisational skills of national federations.
- (c) Flags, banners, posters, rules can be downloaded freely from the FISTF website.
- (d) Countries with little financial resources can request help through the FISTF Development Fund (FISTF MNAs only).
- (e) There are no registration fees for setting up an FISTF Training Centre.

24.4 How to apply

- (a) The **Form F21** (Training Centres Request Form) shall be used for the application.
- (b) You must fill a form for each centre you wish to register.
- (c) The application will be submitted to the General Secretary of FISTF for clearance and consideration from the FISTF board.
- (d) A minimum of 4 photos of the venue shall be included with the application, one photo from outside and three photos from inside.



24.5 Overall Benefits

- (a) All players with a valid FISTF license can use the FISTF Certified Centres for free.

24.6 FISTF Certification

- (a) The application will be submitted to the General Secretary of FISTF for clearance and consideration from the FISTF board.
- (b) A certification diploma shall be issued to all approved Training Centres.

Section 8 Disciplinary Council

F.I.S.T.F. Disciplinary Regulations

Part 1 Rules of Construction

- 1 The provisions of these regulations apply to FISTF, MNAs, Clubs, Players and competition organisers in the conduct of any activity related to sports table football.
- 2 In case of any conflict between the FISTF Statutes and any other section of these regulations, the provisions of the FISTF Statutes shall prevail. The definitions used in the FISTF Statutes shall be used in the interpretation of these regulations.
- 3 If any provision of these regulations or its applicability to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this handbook which can be given effect without the invalid provision or application, and to this end the provisions of these regulations shall be severable.
- 4 In the event of any controversy, dispute or claim arising out of or relating to these regulations, or to the interpretation, breach, or enforcement thereof, the parties shall in good faith use best efforts to settle such controversy, dispute or claim by negotiation. If such negotiation should fail, such controversy, dispute or claim shall be submitted to the FISTF Disciplinary Council (hereinafter 'Council'), which shall issue a final, binding and conclusive ruling on all interested parties.
- 5 The rights and obligations herein contained shall inure to the benefit of, and be binding upon, FISTF, MNAs, Clubs and Players and their respective executors, administrators, successors and assigns.
- 6 Any forbearance of FISTF, MNAs, Clubs or Players to exercise any right or remedy to which they are entitled to under these regulations shall not be construed as a waiver of, or preclude the exercise of, any right or remedy.
- 7 Any case not provided for in, but related to, these regulations shall be referred to the Council, which shall issue a final, binding and conclusive ruling on the case.

Part 2 Organisation and Responsibilities

Article 1 FISTF Disciplinary Council

- 1.1 The management of disciplinary matters within FISTF is entrusted to the Council, as defined in the FISTF Statutes, Article 201, with the sole exception of the authority to pronounce the exclusion of an MNA, which is reserved by the FISTF Congress in accordance with Article 23.3 of the FISTF Statutes.
- 1.2 The Council is composed of three disciplinary judges appointed and revoked in accordance with Article 20 of the FISTF Statutes (hereinafter 'Judges'), by the FISTF Board of Directors who will be agents of FISTF when exercising their official duties. Once appointed, these Judges will appoint a Council Chairman among themselves (hereinafter 'Chairman'). Should the Judges fail to appoint a Chairman within three months of full manning of the Council, the matter shall be referred to the FISTF Board of Directors (hereinafter 'Board'), who may take any measure it deems appropriate, including but not limited to the revocation of the mandate of one or more Judges and the appointment of a Chairman.
- 1.3 The FISTF President can become an ex-officio member of the Council, in a non-voting role, but to assist with procedures and preparation of documents.

- 1.4 The Chairman is responsible for the coordination of the activities of the Council and for the handling of all claims and correspondence addressed to the Council. The Chairperson may delegate this latter responsibility to another member of the Council.
- 1.5 The Council is responsible for the revising, drafting and promulgation of the FISTF disciplinary regulations in accordance with Article 21 of the FISTF Statutes. For that purpose, it will consult within FISTF on the efficiency of the rules and produce changes as it deems necessary.
- 1.6 The Council is responsible for the enforcement of the FISTF disciplinary regulation and to impose disciplinary sanctions in accordance with Article 21 and Article 23 of the FISTF Statutes. For that purpose, the Council will render disciplinary judgements (hereinafter 'Judgement').
- 1.7 When the Council has to make a decision related to 1.5 or 1.6 above, it will first of all attempt to reach a consensus of all its members. Should the Chairman consider, after a reasonable period of discussions, that a consensus cannot be achieved, the Chairman will call for a vote of the Judges, and the decision will be taken by a simple majority of the votes cast. In case of equality of the votes cast, the Chairman will have the casting vote. The deliberations and votes of the Council will be secret.
- 1.8 During the discussions leading to a decision related to 1.5 or 1.6 above, the Council may conduct hearings of the parties and witnesses, and consult with competition organisers, MNA and Club representatives, independent experts and Board members.
- 1.9 Decisions of the Council do not have to be made within the frame of formal meetings, and may be achieved through any reasonable method, including but not limited to informal meetings and e-mail or telephone exchanges. The Chairman will use their best endeavours to involve equally all Council members in the discussions leading to such decisions.

Article 2 Specific Obligations of Council Members

- 2.1 The members of the Council, as well as the members of the Board, who are sanctioned for disciplinary reasons according to these Disciplinary Regulations, will be punished exemplarily with the greatest sanction that applies to the specific infraction.
- 2.2 Members of the Council may not accept from any person instructions, orders, gifts or bribes of any kind that could be related to the exercise of their official duties as Judges. If a member of the Council becomes aware that another Council member has accepted such instructions, orders, gifts or bribes, the member will inform the Chairman and/or the FISTF President as soon as possible.
- 2.3 Members of the Council have to inform the other Council members if they are themselves parties in a proceeding before the Council (either plaintiff or defendant), are related in the first degree (husband, wife, recognised partner, father, mother, son, daughter, brother or sister) to a party in such a proceeding, or are affiliated in another way with a party in such a proceeding (such as holding a management function in a Club that is a party to such a proceeding).
- 2.4 Members of the Council must perform their official duties as Judges with utmost impartiality, fairness, and without any discrimination on the grounds of citizenship, gender, age, marital status, employment, education, race, religion, or sexual or political orientation.

Article 3 Competition Organisers and/or Head Referees

- 3.1 The Council may delegate to the organisers of FISTF competitions and/or the head referee to such competition the power to decide if an action by an MNA, Player or Club is in breach of these disciplinary regulations and refer the relevant party to the Council.

- 3.2 This will be limited to cases where the Council itself, or a member, is not present to make a referral for judgement and sentence.

Part 3 Disciplinary Sanctions

Article 4 Disciplinary Sanctions against Players and Clubs

4.1 In accordance with Article 23 of the FISTF Statutes, FISTF Clubs and Players who are judged by the Council to have breached the present disciplinary regulations, will be sentenced by the Council or its delegate, according to the extent of their actions, to one or more of the sanctions below (sanctions may be combined or added one to another as decided by the Council):

- (a) Official warning;
- (b) Fine;
- (c) Deduction of a defined number of world ranking points;
- (d) Deduction of part or all the world ranking points gained in a specific tournament;
- (e) Disqualification from a specific match;
- (f) Disqualification from a specific competition;
- (g) Disqualification from a specific competition for a specified period up to one (1) calendar year;
- (h) Suspension from participation in defined FISTF competitions (e.g. in a specified country or countries) for a specified period up to one (1) calendar year;
- (i) Suspension from participation in all FISTF competitions for a specified period up to one (1) calendar year;
- (j) Exclusion from FISTF.

4.2 Defined Disciplinary Council sanctions:

- (a) Assaulting a referee or a player: One-year ban and loss of all world ranking points. Before the player is allowed to compete again, they must write a formal apology to the table football community.
- (b) Threatening violence on a referee or player: Six months ban and 500 points. Before the player is allowed to compete again, they must write a formal apology to the table football community.
- (c) Insults, abuse, threats to player, referee or officials: Loss of all ranking points from the relevant event, a one-month ban, additional penalty of the loss of 100 ranking points, and a fine of 100 euros and the requirement to write a formal apology to the table football community..
- (d) Poor behaviour, aggression, failing to follow the rules (persistent breaches of Rule 6.3(c)(iii), resulting in yellow, orange or red card): Loss of all ranking points from the relevant event, a fine of 50 euros and the requirement to write a formal apology to the table football community.
- (e) The consumption of alcohol in the playing venue by referees or players who are still likely to participate in the competition is strictly forbidden. This excludes players who have completed their competition duties for the day or spectators. Penalty for breaking this regulation: Loss of 100 ranking points.
- (f) Repeating of any of the above behaviour should result in a penalty worth double the original penalty.

Article 5 Disciplinary Sanctions against MNAs

- 5.1 In accordance with Article 23 of the FISTF Statutes, FISTF MNAs who are judged by the Council to have breached the present disciplinary regulations, will be sentenced by the Council or its delegate, according to the extent of their actions, with one or more of the sanctions below (sanctions may be combined or added one to another as decided by the Council):
- (a) Official warning;
 - (b) Fine;
 - (c) Disqualification from a specific match;
 - (d) Disqualification from a specific competition;
 - (e) Disqualification from a specific competition for a specified period up to one (1) calendar year;
 - (f) Suspension from participation in defined FISTF competitions (e.g. in a specified country or countries) for a specified period up to one (1) calendar year;
 - (g) Suspension from participation in all FISTF competitions for a specified period up to one (1) calendar year;
 - (h) Exclusion from FISTF.
- 5.2 Defined Disciplinary Council sanctions:
- (a) During a National Team match or tournament, a player or official representing an MNA, assaulting a referee or a player: One-year ban and loss of all world ranking points.
 - (b) During a National Team match or tournament, a player or official representing an MNA, threatening violence on a referee or player: Six months ban and 500 points. Before the National Team can compete again, the MNA must write a formal apology to the table football community.
 - (c) During a National Team match or tournament, a player or official representing an MNA, making insults, abuse, threats to player, referee or officials: Loss of all ranking points from the relevant event, a one-month ban, additional penalty of the loss of 100 ranking points, and a fine of 100 euros and the requirement to write a formal apology.
 - (d) During a National Team match or tournament, a player or official representing an MNA, exhibiting poor behaviour, aggression, failing to follow the rules (persistent breaches of Rule 6.3(c)(iii), resulting in yellow, orange or red card): Loss of all ranking points from the relevant event, a fine of 50 euros and the requirement to write a formal apology.
 - (e) During a National Team match or tournament, a player or official representing an MNA consuming alcohol in the playing venue, while acting as a referee or player, or still likely to participate in the competition shall be strictly forbidden. This excludes players who have completed their competition duties for the day or spectators. Penalty for breaking this regulation: Loss of 100 ranking points for the National Team.
 - (f) Repeating of any of the above behaviour should result in a penalty worth double the original penalty.

Article 6 The Official Warning

- 6.1 An official warning is a letter written by the Chairman to a defendant who has been judged by the Council guilty of a breach of these disciplinary regulations. The Council may decide

that this letter will also be sent to other parties such as the defendant's Club or MNA, as well as the FISTF Board.

- 6.2 The Council will keep a register of all official warnings. This register must be kept electronically on a suitable web-accessible database, with access by the FISTF President and Secretary General.

Article 7 The Fine

- 7.1 A disciplinary fine is a pecuniary obligation of a defendant who has been judged by the Council guilty of a breach of these disciplinary regulations and sentenced to pay a fixed amount of money. Fines will be defined by the Council in multiples of 10€.
- 7.2 An MNA, Player or Club sentenced to a fine will be automatically suspended from participating in any FISTF competition until this fine is fully paid, unless the Council decides otherwise.

Article 8 The Disqualification

- 8.1 The disqualification of a defendant who has been judged guilty of a breach of these disciplinary regulations results in the defendant automatically losing the match and/or competition(s) from which they are disqualified.
- 8.2 If the disqualification is for one match, the defendant will lose the match with a minimum of 0-3 for an individual match, and of 0-4 for a team match. If the match was ongoing at the time of disqualification and had a more detrimental result against the defendant, such higher score will be kept.
- 8.3 If the disqualification is for one or more competitions, the defendant will lose all matches of that competition with a minimum of 0-3 for an individual match, and of 0-4 for a team match. If a match of the defendant was ongoing at the time of disqualification and had a more detrimental result against the defendant, such higher score will be kept.
- 8.4 The disqualification of a defendant may be decided by the Council or, by delegation, by a competition organiser and/or head referee. The disqualification is the only disciplinary sanction that the Council may allow a delegate to decide on. In that case, the delegate may only sentence the defendant to a disqualification for the match(es) and/or competition for which they are organiser and/or head referee.
- 8.5 When a defendant is sentenced to disqualification by a delegate of the Council, that delegate or a third party may in addition file a claim to the Council for the same facts. Should this be the case, the Council may decide to sentence the defendant to an additional sentence.
- 8.6 The decision of a delegate of the Council to disqualify a defendant for a match and/or a competition is final and may not be appealed or modified. The Council or FISTF will not hold any liability, monetary or otherwise, towards the defendant for that disqualification.

Article 9 The Suspension

- 9.1 A suspension is an interdiction of a defendant who has been judged by the Council guilty of a breach of these disciplinary regulations to play some or all future FISTF competitions for a defined period of time of up to one (1) year.
- 9.2 A suspended defendant will lose all the benefits of FISTF affiliation for the duration of the suspension as defined in the sanction, while still retaining all their FISTF obligations.
- 9.3 The suspension of an MNA will automatically imply the suspension of all Clubs and Players affiliated with that MNA.

- 9.4 The suspension of a Club will automatically imply the suspension of all Players affiliated with that Club.

Article 10 The Exclusion

- 10.1 The exclusion of a defendant who has been judged by the Council guilty of a breach of these disciplinary regulations is a revocation of the membership and/or affiliation with FISTF for that defendant. The exclusion implies the indefinite suspension from all FISTF competition.
- 10.2 When the Council decides to exclude a Player or Club from FISTF, this exclusion will only become effective when ratified by the Board.
- 10.3 When the Council decides to propose the exclusion of an MNA from FISTF, this exclusion may only be pronounced by a decision of the Congress.
- 10.4 Even after it has been excluded from FISTF, an MNA, Club, Player, its successors and assignees, shall remain liable for any obligation, monetary or otherwise, incurred when it was an FISTF Member or associated with FISTF.
- 10.5 FISTF will have no liability whatsoever, monetary or otherwise, towards an excluded defendant, unless these liabilities were incurred prior to the exclusion.

Article 11 Sentencing Guidelines

- 11.1 The Council will publish sentencing guidelines, where it will present, for several types of breach of these disciplinary regulations, the associated sentences. These sentencing guidelines will be used by the Council and its delegates in further sentencing, without the Council being thereby bound to these guidelines. (see Article 4.2 and 5.2)
- 11.2 The Council will update these sentencing guidelines on a regular basis.
- 11.3 The sentencing guidelines are additional to, and do not replace, the provisions of these regulations.

Part 4 Substantive Disciplinary Regulations

Article 12 General Duties and Obligations

- 12.1 *Obligation of ethical behaviour:* The MNAs, Players and Clubs to which the present regulations apply must maintain a behaviour consistent with the athletic standards of fairness and morals, in all their actions, during the sport, as well as during their financial or social actions having to do with FISTF. All players, in whatever role, registered with FISTF, have an obligation to maintain the best interests of the sport, and refrain from any action or words which would bring the game or FISTF into disrepute.
- 12.2 *Obligation to produce documents:* All FISTF MNAs, Players and Clubs are obliged to provide the Council with any information in their possession that the Council requests them to provide during disciplinary proceedings. In case of failure to comply, the Council may decide that they will be punished with a fine.
- 12.3 *Obligation to testify:* If a FISTF MNA, Player or Club is called as a witness in disciplinary proceedings by the Council and refuses to testify, the Council may decide that they will be punished with a fine.
- 12.4 *Obligation to maintain the secrecy of proceedings:* The FISTF MNAs, Players and Clubs who are taking part in disciplinary proceedings are forbidden to make any public declarations related to these proceedings or to make public comments related to other parties to, or persons involved in, such proceedings. They are also forbidden to supply to anyone information regarding disciplinary proceedings that are not yet finalised. In case of failure to comply, the Council may decide that the transgressor will be punished with a fine.

- 12.5 *Obligation to refrain from inciting violence:* FISTF MNAs, Players and Clubs may not publicly make declarations, indirectly or directly, which could, in the opinion of the Council, incite others to use any type of violence. In case of failure to comply, the Council may decide that the transgressor will be punished with a suspension from participating in any FISTF Tournament. The Council may also decide to propose to the Board (for Players or Clubs) and/or the Congress (for an MNA) the exclusion from FISTF.
- 12.6 *Obligation of truthful and complete answers:* FISTF MNAs, Players and Clubs are obliged to send to the Council, full, correct and honest answers to every question addressed to them. In case of failure to comply, the Council may decide that the transgressor will be punished with a fine. In addition, the Council may decide that the transgressor will be punished with a suspension from defined FISTF events.

Article 13 General Obligations of Players and Clubs

- 13.1 *Obligation to refrain from unduly influencing a match result:* The Club, team or Player whose actions lead to the abnormal conduction of a match will be sanctioned by the competition head referee or, in their absence, by the competition organiser with immediate disqualification of the specific match. The sanction of immediate disqualification can be given to both Players of a match when they both have the same responsibility for the above.
- 13.2 When there are facts that cannot be technically proved during a match, the Council may examine and judge if the result or the conduction of a match in general was normal. In that case, the Council may disqualify one or both the opponents, or order a replay of the match if it was not played.
- 13.3 *Liability of Club representatives:* The Players who are appointed to legally represent their Club are presumed to be equally liable, until the opposite is proved, for any breach of disciplinary regulations by their Club.
- 13.4 *Liability of team captains:* The Player who is the Captain of a Team in a specific game is liable according to the present handbook for any breach of disciplinary regulation by their team. This responsibility for the specific delinquency can be reduced if another specific member of their team is held liable.

Article 14 Special Obligations of Clubs

- 14.1 Clubs may reply directly to FISTF or the Council through their official representative, according to the FISTF rules.
- 14.2 *Vicarious liability of Clubs:* Clubs may be held vicariously liable for the acts of their representatives and may face equally any consequence in the case of one of their representatives is found in breach of these disciplinary regulations.
- 14.3 *Liability for negligent oversight:* The Council may decide of its own initiative to enter Judgement and sanction on Clubs that negligently fail to make sure that their Players do not breach these disciplinary regulations.
- 14.4 *Obligation of internal control:* A breach of a disciplinary regulation by a Player member of a Club will not automatically lead to the liability of their Club. However, if a Player is sentenced by the Council, their club has the obligation to sanction him internally.
- 14.5 *Obligation not to employ suspended or disqualified Players:* The sanction of disqualification will be given to a Club by the competition head referee or, in their absence, by the competition organiser which uses suspended or disqualified Players during a competition, or Players who in general have no right to play.

Article 15 Special Obligations of Players

- 15.1 *Obligation of restraint:* Players will show restraint during competitions, whether they are presently engaged in a match. In particular, the following will be considered as a breach of these disciplinary regulations:
- (a) Negative criticism or harmful comments about another Player, Club, a referee, the head referee, a third party, the competition organiser or an MNA. Behaviour or declarations which are capable of leading to acts of violence.
 - (b) Deliberate breach of the present regulations or of the FISTF rules of the game, with the intent to change the normal course of a match.
 - (c) Exaggerated celebration of a win or a goal, which could be considered as an insult to the opponent.
 - (d) Swearing during the match against anyone.
 - (e) Insults against another Player, Club, a referee, the head referee, a third party, the competition organiser or an MNA.
 - (f) Denial of a request to referee or absence during a mandatory refereeing.
 - (g) Threat or attempt to use force against another Player, a referee, the head referee, a third party, or the competition organiser.
 - (h) Unlawful use of force against another Player, the referee, the head referee, a third party, or the competition organiser.
 - (i) Damage of the opponents' or a third party's equipment.
 - (j) Damage of the equipment used for the competition.
 - (k) Repeated violation of referee duties.
- 15.2 Players breaching the above obligation will be punished according to the extent of their actions, with one or more of the following sanctions (sanctions can be combined or added one to another):
- (a) For the cases 15.1(a) to 15.1(f): The delegate of the Council may sentence the offender to disqualification from a match or disqualification from the competition. In addition, the Council may give the defendant an Official Warning and/or a fine.
 - (b) For the cases 15.1(g) to 15.1(j): The delegate of the Council may sentence the offender to disqualification from a match or disqualification from the competition. In addition, the Council may sentence the defendant to any disciplinary sanction.
 - (c) For the case 15.1(k): The delegate of the Council may give the defendant an Official Warning and/or a fine.
- 15.3 For the sentencing of all breaches of the obligation of restraint, the delegate of the Council, or the Council itself may consider acts of provocation or a breach of these disciplinary regulations by the victim, as extenuating circumstances.

Article 16 Red Cards Records System

- 16.1 The Council will hold a record of the Red Cards that have been issued to Players in accordance with the FISTF rules of the game.
- 16.2 In addition to the sanctions referred to Article 15, the following sanctions will be given by the Council:
- (a) Player who has been issued two (2) Red Cards during the same sports season (September to August): Loss of 200 World ranking Points and any fine;

- (b) Player who has been issued three or four (3 or 4) Red Cards during the same sports season: Loss of 200 World Ranking points, a fine, and a 3 months' disqualification from any FISTF competition;
- (c) Player who has been issued five (5) Red Cards or more during the same sports season: Loss of a minimum of 300 World Ranking points, any fine, and disqualification from any FISTF competition for a minimum of one (1) year.

Article 17 Orange Cards Records System

- 17.1 The Council will hold a record of the Orange Cards that have been issued to Players in accordance with the FISTF rules of the game.
- 17.2 In addition to the sanctions referred to Article 15, the following sanctions will be given by the Council:
- (a) Player who has been issued three or four (3 or 4) Orange Cards during the same sports season: Loss of 50 World Ranking points, and a 40 Euro fine;
 - (b) Player who has been issued five or six (5 or 6) Orange Cards during the same sports season: Loss of 150 World Ranking points, any fine, and a 2 months' disqualification from any FISTF competition;
 - (c) Player who has been issued seven (7) Orange Cards or more during the same sports season: Loss of 200 World Ranking points, any fine, and a 3 months' disqualification from any FISTF competition. The Council may decide, depending on the number of cards and/or the specific cases, if the player should get any additional sanction.

Article 18 Yellow Cards Records System

- 18.1 The Council will hold a record of the Yellow Cards that have been issued to Players in accordance with the FISTF rules of the game.
- 18.2 In addition to the sanctions referred to Article 15, the following sanctions will be given by the Council:
- (a) Player who has been issued four (4) Yellow Cards during the same sports season: Loss of 50 World Ranking points, and a 20 Euro fine;
 - (b) Player who has been issued five to seven (5 to 7) Yellow Cards during the same sports season: Loss of 100 World Ranking points, any fine, and a 1-month disqualification from any FISTF competition;
 - (c) Player who has been issued eight (8) Yellow Cards or more during the same sports season: Loss of 150 World Ranking points, any fine, and a 3 months' disqualification from any FISTF competition. The Council may decide, depending on the number of cards and/or the specific cases, if the player should get any additional sanction.

Article 19 Cards Records System - Combinations

- 19.1 In addition to the sanctions referred to Article 16, Article 17 and Article 18, the Council may give a sanction to a player who has a combination of Red/Orange/Yellow cards. Any player having two (2) or more cards in each category (e.g. 2 Orange & 2 Yellow) and even if according to Article 16, Article 17 and Article 18 they would get no sanction, may be sentenced by the Council according to its judgment.

Article 20 Recurring Breaches of Disciplinary Regulations

- 20.1 A Club or Player who, after they have been sentenced by the Council according to the present disciplinary regulations, fails to comply with the sentence and/or breaks the same or any other rule repeatedly, will receive a stronger sanction.
- 20.2 To be considered as recurring breaches, the breaches must have occurred during the last two (2) sports seasons.

Part 5 Rules of Procedures of the FISTF Disciplinary Council

Article 21 Filing of Claims

- 21.1 Notwithstanding the rights of the Head Referee and Tournament Organisers outlined in Section 6 of the regulations, when FISTF, an MNA, Player or Club becomes aware of a possible breach of these disciplinary regulations, they may file a claim reporting such breach. This must be reported to the Council within thirty (30) calendar days of the presumed breach. Such claim will be addressed to the Council Chairman, or the person to whom they have given the authority to process claims.
- 21.2 Claims must be filed in writing by one named plaintiff against one or more named defendants. FISTF, MNAs, Clubs and Players may be plaintiffs or defendants. Such claims will set out in sufficient detail the charges against the defendant, and will list as a minimum:
- (a) The names and contact details of the plaintiff;
 - (b) The name of the defendants in sufficient details to allow the Council to identify them;
 - (c) A description of the facts presumed to be a breach of these disciplinary regulations, including but not limited to time and place information;
 - (d) If possible, the mention of the part of the disciplinary regulations that the plaintiff considers have been breached;
 - (e) A description of the prejudice caused to the plaintiff by the presumed breach, if any.
- Should the initial claim, in the opinion of the Council, not contain sufficient information, the Chairman will contact the plaintiff in order to collect that information. The plaintiff will be responsible to provide the missing information to the Council.
- 21.3 Should the Council decide that the plaintiff has not provided sufficient information to allow the Council to render a Judgement, the claim will be dismissed as inadmissible. The Chairman will inform in writing the plaintiff as soon as possible of such decision.
- 21.4 Should the Council decide that the claim is admissible, the Chairman will inform in writing as soon as possible the defendant of the details of the claim and charges against him, and that the defendant may file a written explanatory memorandum in their defence to the Council within thirty (30) calendar days of the date of the Chairman's message.

Article 22 Proceedings before the Council

- 22.1 For the investigation of the claim, the Council may request the production of other supporting documentation, such as Match Report, Referee's Reports, Head Referee's Report, Report of the Competition Manager and the defendant's apology letter. Upon receipt of the Council request for the production of such supporting documentation, the document holder has the obligation to provide a copy of the requested document to the Council.
- 22.2 Proceedings before the Council will be accusatory. Both plaintiff and defendant will be invited to present their case before the Council. This presentation does not have to be made within the frame of formal hearings and may be achieved through any reasonable method as

determined by the Council, including but not limited to informal meetings and e-mail or telephone exchanges.

- 22.3 Should the Council decide that a preponderance of the available evidence suggests that a breach of the disciplinary regulations did take place, the Chairman will request the defendant to submit an apology letter to the plaintiff and/or any part that has suffered damages from the breach, with a copy to the Chairman. The defendant will have to submit such apology letter in writing within ten (10) days of the Council decision.

Article 23 Judgement

- 23.1 Based on the available evidence and on the apology letter of the plaintiff, if any, the Council will render a Judgement, where it will decide that a preponderance of the available evidence suggests that the defendant is:

- (a) Guilty of one or more breaches of the disciplinary regulations, and will then sentence the defendant to one or more disciplinary sanctions; or
- (b) Not guilty of a breach of the disciplinary regulations.

Such Judgement will be supported by a reasoned opinion approved by the Council that sets-out the reasons for the Judgement and sentence.

- 23.2 A defendant may be found guilty of breaches of the disciplinary regulations that were not listed among the charges in the original claim.
- 23.3 In rendering Judgement, the Council will use as guidelines previous Judgements of the Council and the applicable sentencing guidelines but will not be bound by such Judgements or guidelines.
- 23.4 In sentencing the defendant to a disciplinary sanction, the apology letter of the defendant, if any, will be considered as a mitigating circumstance.
- 23.5 When more than one claim is filed against the same defendant for the same facts, only one Judgement may be rendered against the defendant (no double jeopardy). However:
- (a) When additional claims are filed after Judgement has been rendered, that add new facts that the Council decides to be relevant to the original charges, the Council may decide to reopen the disciplinary proceeding;
 - (b) A claim that has been dismissed as inadmissible will not preclude the filing of another claim against the same defendant for the same facts.
- 23.6 The Chairman will inform in writing as soon as possible the plaintiff and the defendant of the Judgement rendered by the Council and of the related sentence. In addition, the Judgement and sentence will be published as soon as possible on the FISTF official website www.fistf.com.

Article 24 Execution of Disciplinary Sanctions

- 24.1 Any disciplinary sanction will become effective and its execution will start on the day following the publication of the sentence on the FISTF official website, unless the Council decides otherwise in the Judgement.
- 24.2 The execution of a sentence will be suspended during the duration of the proceedings that follow the admission by the Council of an appeal from the related Judgement. The period between the start of the execution of the sentence and the suspension of the disciplinary sanction will be deducted from the duration of any new disciplinary sanction imposed by the Judgement in appeal.
- 24.3 If a sentence cannot be fully executed during a sports season, it will continue during the next sports season(s).



- 24.4 If a Player is transferred to another Club and/or MNA, they will normally continue their sentence, even if for example a whole team to which they are not member anymore had been sanctioned.

Article 25 Appeal

- 25.1 The plaintiff, the defendant or both may, within thirty (30) calendar days of the publication of the Judgement on the FISTF official website, appeal from a Judgement and/or sentence by writing to the Chairman.
- 25.2 Should the Council decide that the plaintiff, the defendant or both have not provided any additional evidence that could lead the Council to review its Judgement and/or sentence, the relevant appeal will be dismissed as inadmissible.
- 25.3 Should the Council decide that an appeal, either by the plaintiff, the defendant or both, is admissible, the Council will suspend the Judgement and the execution of the sentence. The Chairman will inform as soon as possible the plaintiff and the defendant.
- 25.4 Following the suspension of the initial Judgement, the Council will re-start the proceedings and render a new Judgement as described in Article 2 and Article 3.

Article 26 Miscellaneous Provisions

- 26.1 When a member of the Council is a party in a proceeding before the Council (either plaintiff or defendant), is related in the first degree (husband, wife, recognised partner, father, mother, son, daughter, brother or sister) to a party in such a proceeding, or is affiliated in another way with a party in such a proceeding (such as holding a management function in a Club that is a party to such a proceeding), they will not take part in the decisions of the Council related to that proceeding.

In cases where a member of the Council absents themselves because of 26.1, the Chairman of the Council may appoint a suitable replacement member for the period of the proceedings.

- 26.2 For the purpose of these rules of procedure, written documents will include, but not be limited to manuscripts, typed letters, faxes, e-mails (and their attachments) and cell phone text messages. In case of doubt, the Council will decide if a specific communication is a written document.

Timeline (1st September – 31st August each year)

- 1st September
 - Updated **Form F01** (some of those things included should have been already sent when paying the membership fee for the following season)
 - **Form F20** of all associations (licensed players and clubs and national transfers)
- 1st September – 1st March
 - collecting ideas for changes in handbook/rules/homologation from associations
- 1st March – 1st April
 - Letter with information about proposed changes to the Handbook to be sent to the MNAs, each point should be listed, and it should be possible for associations to vote about the change at least.
- 1st April
 - membership payments for the following season must be sent out to all MNAs by the financial department, request an updated **Form F01** with the information needed for a membership
 - publish the new valid release of the handbook
- 1st April – 30th April
 - List of Major candidates to be published on Website and Facebook, according to HB
 - Assign the Major tournaments by 30th April
- 30th April
 - Letter to the MNAs with the dates of the Major tournaments, World Cup and Continental Championships and Champions League/Europa League, publishing 'draft' calendar version on FISTF website.
 - Ask MNAs to nominate their requested events, following the requirements:
 - Membership of the MNA is paid for the following season
 - no open payments of tournament organisers and/or MNA (fines or something similar)
 - updated **Form F01** has been submitted
- 15th May
 - Letter to the MNA with information for the WC (list of qualified players from the WR, and registration form for the WC)
- 20th May
 - Letter to the MNAs with the approved events (Majors, Grand Prix, FISTF WC, FISTF Continental Championships, FISTF Champions League/Europa League, FISTF Continental Team Competition), Publishing the calendar on FISTF HP

- All other types of tournaments can be requested after that, all those events which were already sent with the requests of Grand Prix will be added after that, publishing calendar regularly on FISTF HP with updates.
- 15th June
 - Letter to the MNAs with information about the CL/EL of the following season (qualified teams from the WR and registration form)
- 30th June (in World Cup Year)
 - Deadline of registration for the World Cup
 - Sport department makes the starter list and informs the associations who are the substitutes who can play the individual too
 - Publish starter list and list of substitutes in order
- 31st July
 - Deadline for the registration for CL/EL
 - Sports department makes a starter list and information to the substitute teams which can take part in the competition. List of substitutes and order
- General activities during the season:
 - Appointing of head referees by the sports department till latest Thursday every week, when there is an event on the following week-end where a head referee is necessary according on the handbook, request the starter lists from the organisers or refer to the tournament HP. Maybe it could be good to have a set of Head Referees who are ready to do the job, if they are taking part at the tournament, then it would be easier for sports department to appoint people.
 - Take care that the tournament papers and result sheets are available on the FISTF HP, if not the FISTF sports department must send the papers to all tournament organisers when their events are approved by the sports department.
 - FISTF Financial department should send out the payments latest on 10th of the month for the tournaments of the previous month.
 - Results and tournament papers must be sent in time
 - Use the possibilities of sanctions, especially when Majors, Grand Prix, WC, CC and/or CL/EL are organised.
 - Every request for tournaments or transfer must be answered by FISTF officially. If the request is ok a confirmation is needed, if the request is not ok, a refusal must be sent. That work should be done by the Gen. Sec., always based on the FISTF Handbook.
 - FISTF Tour results must be online immediately after FISTF got them. Otherwise it is difficult to ask the results of the events immediately after the event from the organisers, while FISTF isn't using them finally.
 - All important information (forms, etc.) must be available in the latest version on FISTF HP.
 - FISTF Calendar on FISTF HP
 - The tournament homepage (if available) should be available without clicking into the tournament details. They should be added to this page of the calendar
